4/7/21 – MIRU and NU BOP. Dropped 1.25" ceramic ball. Pumped 9-1/2 bbls and pressured up to 1500 psi. Set a CIBP at 2465'. Displaced well with 40 bbls brine mud gel. Tested 4-1/2" casing to 500 psi, good. Spotted 45 sx Class "C" cement on top of CIBP.

4/8/21 – Tagged TOC 1846'. Perforated at 1013'. Pressured up to 500 psi, good. Perforated at 427'. Pressured up to 500 psi, good. Spotted a 75 sx Class "C" cement plug from 1070' up to surface. Note: Procedure called for 3 plugs total. Combined plugs 2 and 3 due to error in procedure. Gilbert Cordero NMOCD-Artesia contacted on issue and gave verbal ok to changes.

4/21/21 - Cut off wellhead. Installed dry hole marker. Cover cellar and cut off anchors. **WELL IS PLUGGED AND ABANDONED.**
