4/9/21 – MIRU and NU BOP. Dropped 1.25" ceramic ball. Pumped 3.75 bbls and pressured up to 1500 psi. Set a CIBP at 1477'. Displaced well with 40 bbls brine mud gel. Tested 5-1/2" casing to 500 psi, tested good. Spotted 25 sx Class "C" cement on top of CIBP.
 4/12/21 – Tagged TOC 1240'. Perforated at 959'. Tested to 500 psi, good. Spotted 25 sx Class "C" cement at 1010'.
 4/13/21 – Tagged TOC 770'. Perforated at 90'. Tested to 500 psi. Achieved full circulation up 5-1/2" x 8-5/8" annulus to surface. Squeezed 25 sx Class "C" cement from 90' up to surface.
 4/22/21 - Cut off wellhead. Installed dry hole marker. Cover cellar and cut off anchors. **WELL IS PLUGGED AND ABANDONED.**
