Pump 20 bbls chem water, 20 bbls visc water, followed by 984 sks of 11.0 ppg lead cmt, 363 sks of 14.8 ppg tail cmt. Drop plug and displace with 398 bbls of freshwater. 150 bbls of cement returned to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 4/30/2021: Drill 8.75 inch second intermediate hole to 11380 ft. 5/3/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11292 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 441 sks of 11.5 ppg lead cmt, 117 sks of 13.2 ppg tail cmt.
