RIH & set 9-5/8" 36# J-55 BTC csg @ 1700', pump 40bbl FWS, then cmt w/ 345 sxs class C w/ additives 12.2ppg 2.33 yield followed by 115 sxs class C w/ additives 13.2ppg 1.85 yield. Full returns throughout job, circ 91 sxs to surface. Test 9-5/8" csg to 1500# for 30 minutes, good test.
