5/3/21 – MIRU and NU BOP. Dropped 1.25" ceramic ball. Pumped 8 bbls and pressured up to 1500 psi, good. Set a CIBP at 1383'. Displaced with 35 bbls brine gel mud. Tested casing to 500 psi, good. Spotted 25 sx Class "C" cement on top of CIBP to 1106', tagged. 5/4/21 – Perforated at 964'. Attempted to establish rate through perf. Tested to 500 psi, good. Spotted a 30 sx Class "C" cement plug from 1029'-730', tagged. Perforated at 96'. Attempted to establish rate thru perf. Tested to 500 psi, good. Spotted a 25 sx Class "C" cement plug from 161' up to surface.
 5/19/21 - Cut off wellhead. Installed dry hole marker. Cover cellar and cut off anchors. **WELL IS PLUGGED AND ABANDONED.**
