Load hole if needed. 3) Well is not perforated. Pressure test will be from surface to 5-1/2" FC @ 1075'. 4) Pressure test casing to 560 psi for 30 mins. 5) Submit pressure test chart to OCD.

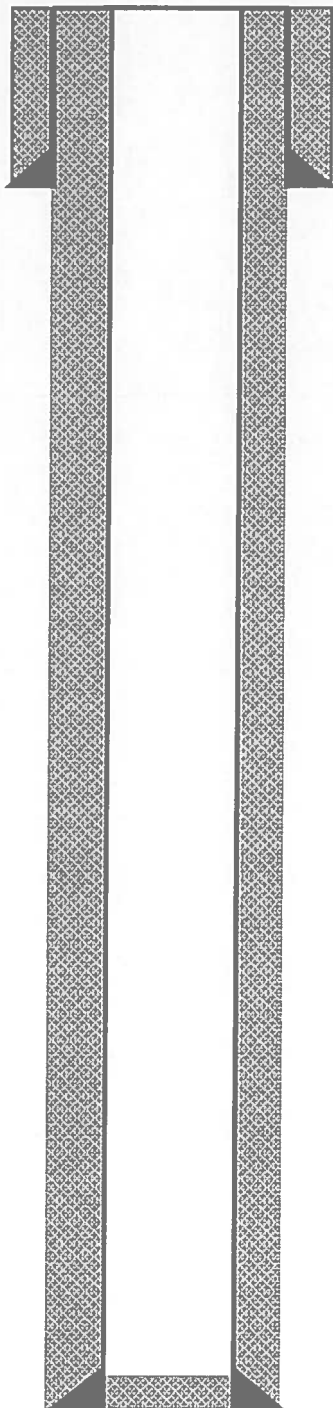

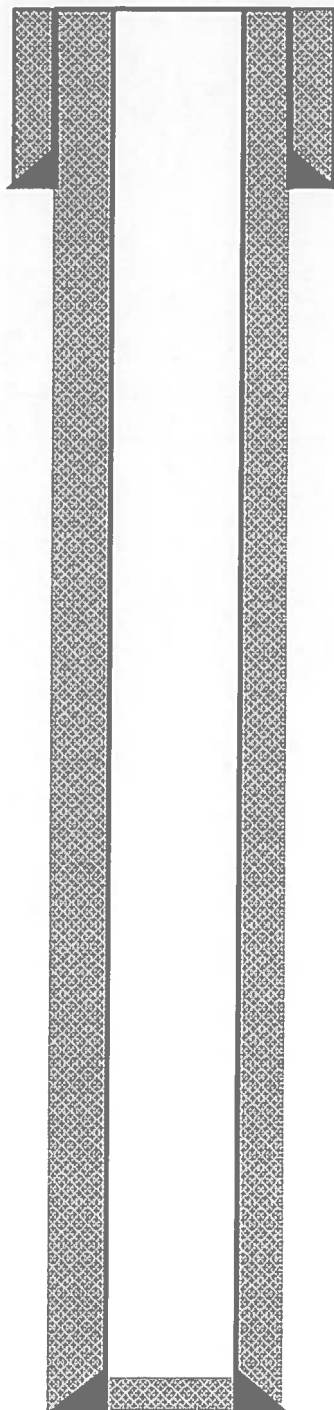
