Cement 13-3/8" surface casing with 560 sx (1.34 cuft/sx) 14.8# Class C w/ 2% Calcium Chloride & 0.25 pps cellophane. Circulate 252 sx cement to surface. WOC 10 hours, test BOP 250 psi low/3000 psi high, held. Test casing to 600 psi for 30 min, held. Drill and TD 12-1/4" hole at 1,510'. Run 39 jts. 9-5/8" 40# J-55 set at 1,505'. Cement 9-5/8" intermediate casing with 350 sx lead(1.72 cuft/sx) 13.5# Class C w/ 4% gel, 0.4pps defoamer & 0.125 pps cellophane & 200 sx tail(1.34 cuft/sx) Class C w/ 2% Calcium Chloride. Circulate 130 sx to surface. WOC 8.5 hours, test casing to 1,500 psi for 30 min, held.
