H&P 556 rigged up on the Beauty Queen Fed Com 604H was re-spud 4/1/2021. Drilled and cased the 1st intermediate section.

Wellbore construction details below:


Drilled 1st intermediate 12.25" hole to 5,165' TD. RIH w/ 112 jts. 9.625" 40 lb/ft, J-55 BTC intermediate casing as follows: Float shoe 1.63', 1 csg joint 46.29', float-collar 1.07', 111 jts. **Landed at 5,062.11'.**

Cemented 9.625" casing as follows: pump 60 bbls of mpe @ 12.5 ppg. Pump 644 bbls (2031 sks) of lead mixed @ 12.8 ppg, followed by 87 bbls (366 sks) of tail mixed @ 14.8 ppg. Drop plug and wash out lines. Displace with 387 bbls. Bumped plug on circ. displacement (FCP = 1400 psi) with 750 psi over final circulating pressure of 2150 psi. Bled back 3.5 bbls. Floats held. Received 20 bbls cement returns to surface. Good cement.
