DESCRIPTION OF WORK:

7/23/21: Spud well @ 5:30 PM.

Drilling **17-1/2" hole**. TD 17-1/2" hole @ 2,088.

7/24/21: 12-1/4" hole; Ran 49 joints of 13-3/8", 54.5#, J-55 surface casing @ 2,077' @ 3:00 PM. Cement w/ lead 1,270 sx CLC, yield 1.80. Tail w/420sxs CLC, yield 1.34. Returns to surface. Circulate 190 bbls back to surface. Test casing to 947# for 30 minutes. Test good.

7/27/21: Drill 12-1/4" Intermediate hole to 5,610'. Work stuck pipe, ream out of hole @4,520', clean hole. Run 183 joints of 9-5/8", 40#, J-55 intermediate csg. to 5,599'.

7/28/21: Cmt. Stage 1, Lead w/740sx Prolite, 3.43 yield; Tail w/200 sxs, CLC, 1.34 yield. Returns to surface; 5 bbls circulated to surface. Will test csg. before running production csg.

8/2/21: Tested intermediate csg. to 1500# for 30 minutes. Test good.
