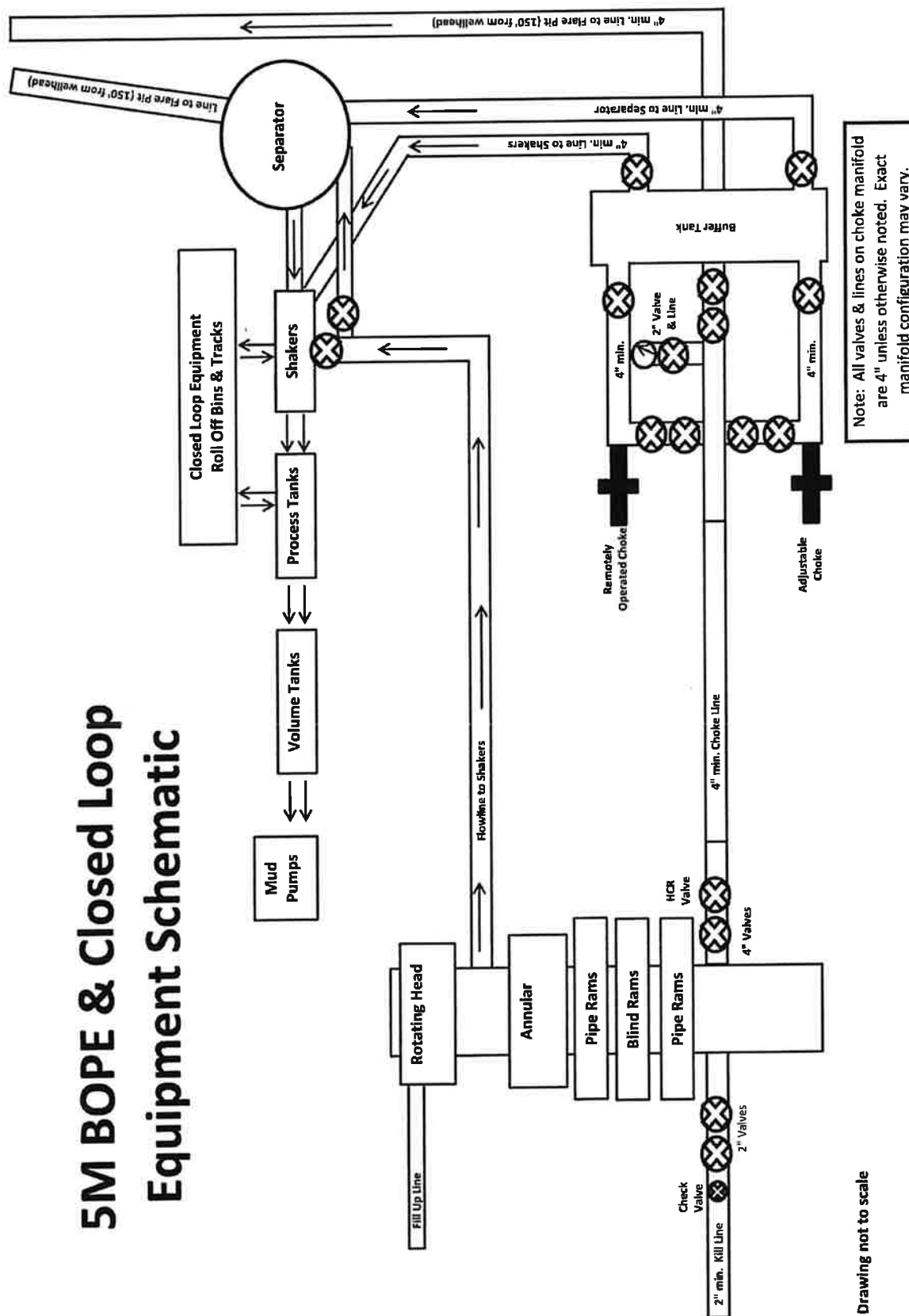

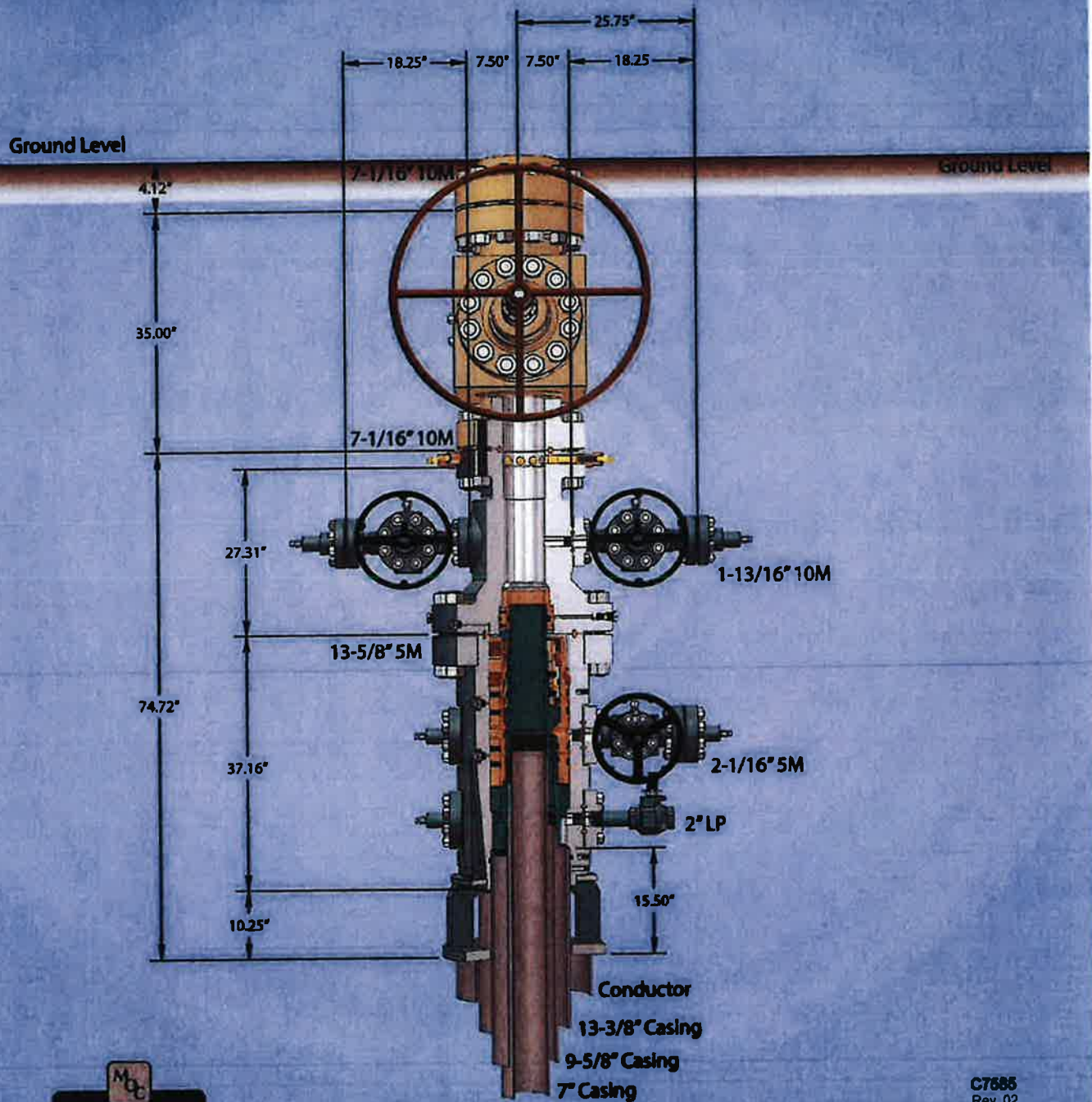
5M BOPE & Closed Loop Equipment Schematic

13-5/8" MN-DS Wellhead System

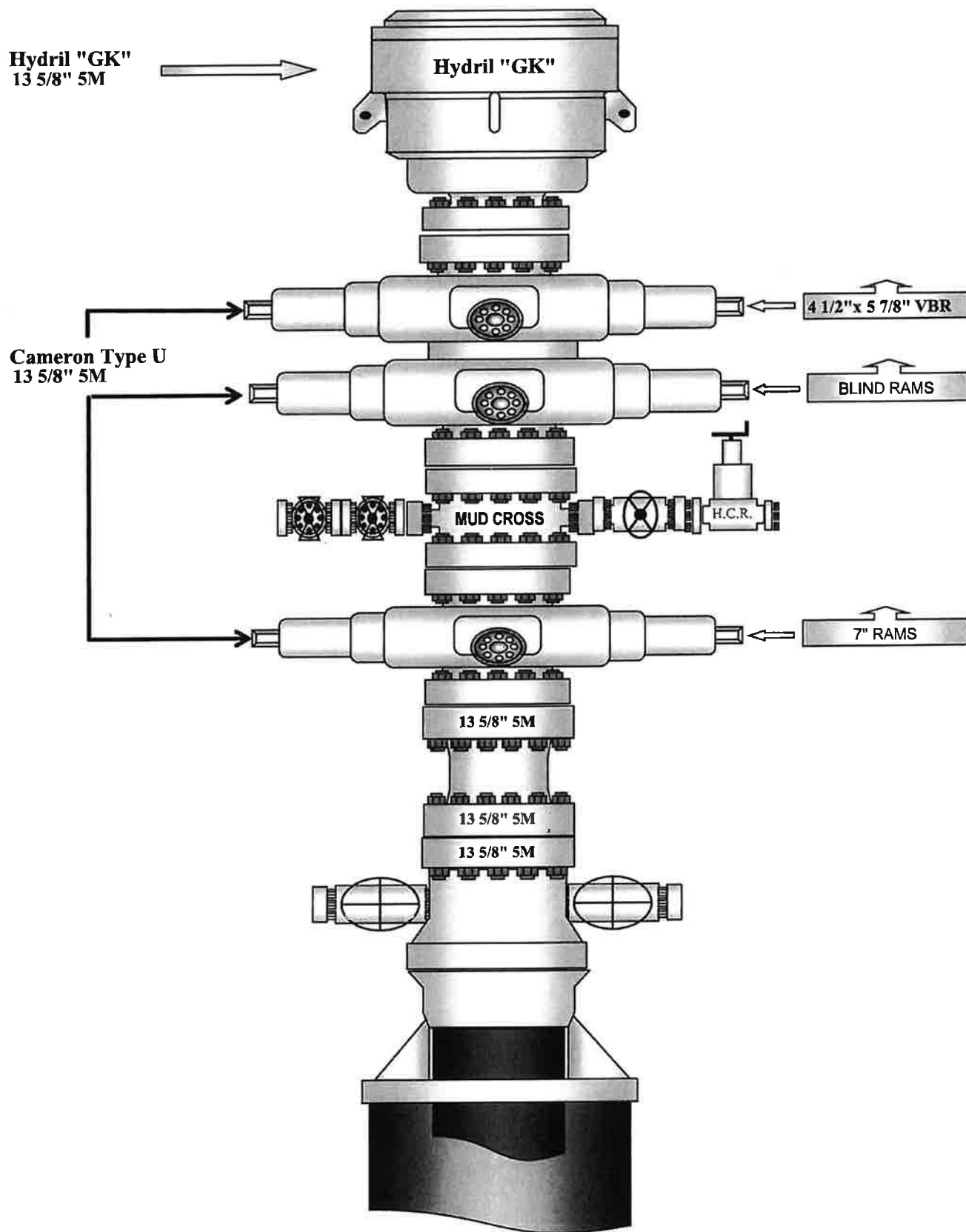
