8/4/21: TD 17-1/2" hole @ 1885. Ran 51 joints surface csg., to 1875'. 13-3/8", 54.4#, J-55. Cement lead cmt., 1020 sxs. 1.80 yield, Prolite; Tail w/420 sxs., 1.34 yield, CLH to surface. 172 bbls. returned to surface.

8/5/21: Test surface csg. 1,000# for 30 minutes. Good test.

8/8/21: TD 12-1/4" hole @ 5538'. Ran 133 joints 9-5/8" intermediate csg., 40#, J-55 to 5528'. Cement lead 820 sxs., 3.43 yield, Prolite; Tail w/200 sxs., 1.34 yield, CLC. Circulate cmt to surface. 64 bbls. returned to surface. Tested intermediate csg. to 1,500# for 30 minutes. Good test. Drill 8-3/4" vertical section to 9977'.
