Switch to 8.75 inch bit and drill intermediate hole to 12560 ft. 7/28/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 12456 ft. Pump 10 bbls chem wash, 10 bbls visc water, 20 bbls mud spacer, followed by 1168 sks of 10.5 lead cmt, 141 sks of 13.2 ppg tail cmt. Drop plug and displace with 570 bbls of fresh water. 220 bbls of cement to surface. Pressure test casing to 2740 PSI for 30 minutes, good test. Intermediate Casing Details: Casing ran 7/28/2021, Fluid Type Cut Brine, Hole 9.875 inch, Csg Size 7.625 inch, Weight 29.7 lbs, Grade P-110, Est TOC 0 ft, Depth set 12456 ft, Cement 1309 sacks, Yield 1.35, Class C, Pressure Held 2740 psi, Pres Drop 0.
