**Actual Procedure:** 8/28/2021: Drill 17.5 inch surface hole to 1306 ft. Run 13.375 inch 54.5 lb J55 surface casing to 1294 ft. Pump 40 bbls gel with CTB-15, followed by 700 sks of 13.5 ppg lead cmt, 420 sks of 14.8 ppg tail cmt. Drop plug and displace with 194 bbls of brine. 170 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. Surface Casing Details: Casing ran: 8/28/2021, Fluid Type Fresh Water, Hole 17.5 inch, Csg Size 13.375 inch, Weight 54.5 lbs, Grade J55, Est TOC 0 ft, Depth set 1294 ft, Cement 1120 sacks, Yield 1.34, Class C.
