Actual Procedure: 8/30/2021: Test BOPS. Drill 12.25 inch first intermediate hole to 5443 ft. 9/1/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 5392 ft. Pump 20 bbls chem wash, 20 bbls spacer, followed by 1155 sks of 11.5 ppg lead cmt, 419 sks of 14.8 ppg tail cmt. Drop plug and displace with 406 bbls of freshwater. 0 bbls of cement returned to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 9/2/2021: Drill 8.75 inch second intermediate hole to 11090 ft. 9/7/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11014 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 443 sks of 10.5 lead cmt, 138 sks of 13.2 ppg tail cmt. Drop plug and displace with 503 bbls of brine. 95 bbls of cement to surface. Pressure test casing to 2440 for 30 minutes, good test.
