Pump 20 bbls chem wash, 20 bbls visc water, followed by 1155 sks of 11.0 ppg lead cmt, 419 sks of 14.8 ppg tail cmt. Drop plug and displace with 490 bbls of freshwater. 0 bbls of cement returned to surface. EST TOC at 518 ft. Pressure test casing to 1500 PSI for 30 minutes, good test. 9/9/2021: Drill 8.75 inch second intermediate hole to 11380 ft. 9/14/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11275 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 458 sks of 10.5 lead cmt, 138 sks of 13.2 ppg tail cmt. Drop plug and displace with 514 bbls of cut brine. 60 bbls of cement to surface.
