1. MIRU WO Rig with Power swivel.
2. Drill out top cement plug inside 5-1/2" casing to 60 ft.
3. RU Eline and jet out 5-1/2 casing at 60'
4. Burn over 60' of 5-1/2" casing with wash pipe.
5. Spear and remove 5-1/2 from well.
6. Clean out 60' of 9-5/8" casing with a bit.
7. Check the 13-5/8 x 9-5/8" annulus for LEL readings.
8. Set CIBP inside 9-5/8 at 60'.
9. Set 25sxs surface cement plug inside 9-5/8" casing.

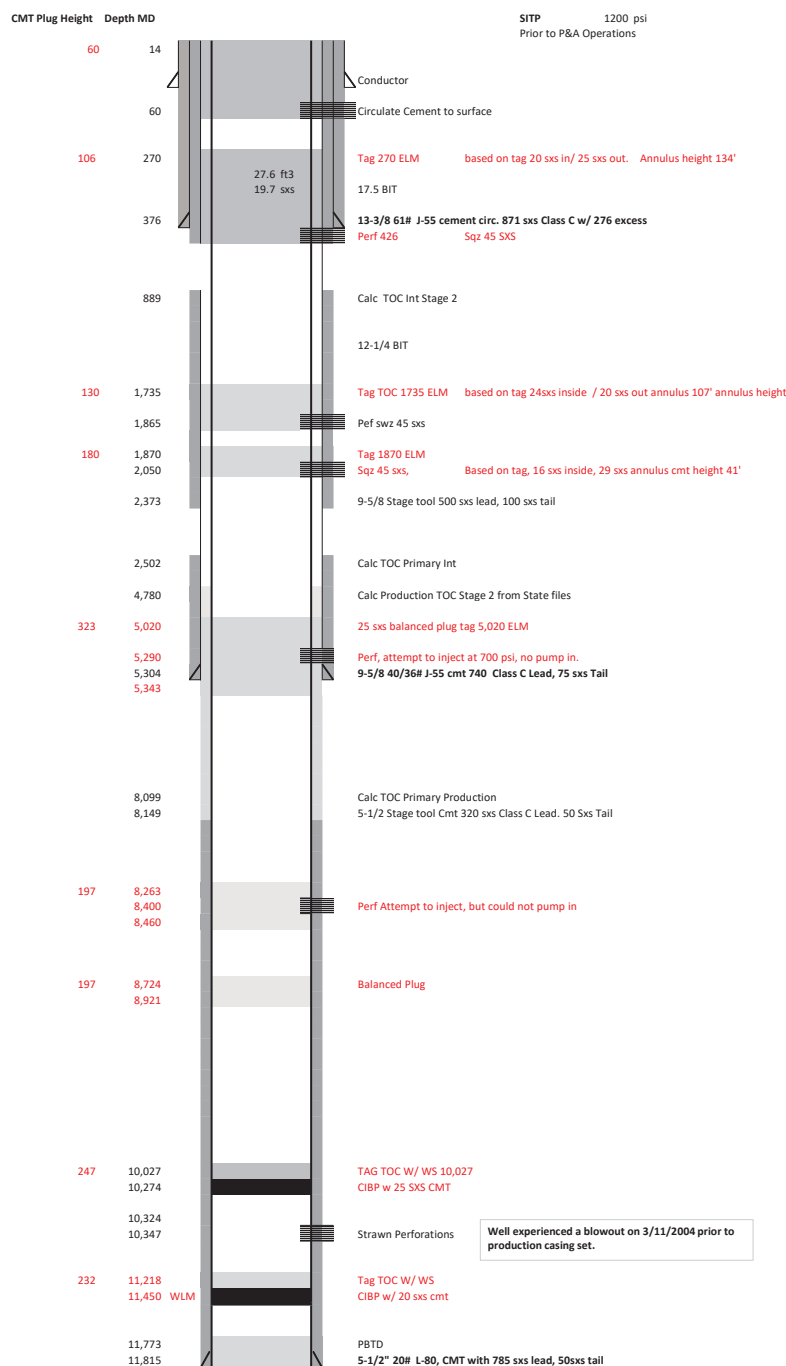
