Planned Procedure

- RUPU, Kill well, ND WH – NU BOP
- RU WL and set blanking plug (BP) (first barrier), RD WL
- hydrotest tubing and casing to ensure good integrity
- Unlatch from injection packer and POOH with ~ 1100' of injection tubing
- RU and screw rest of the injection tubing to the bottom of RBP, RIH with ~1000' of WS (2-7/8" 6.5# J-55 Bare pipe) and set RBP @ ~ 1000' (Second barrier), POOH with WS.
- Dump ~ 1 sx of sand on top of RBP.
- ND BOP and prepare wellhead to be upgraded to CO2 specs
- Replace tubing hanger
- NU BOP
- RIH with WS, circulate sand and latch into RBP, release the same. POOH LD RBP and 1000' of WS
- PU injection tubing (~1100') and RIH
- Circulate packer fluid
- Latch into injection packer
- ND-BOP – NU WH installing new CO2 Tree
- RU WL and fish BP, RD WL
- Run MIT, return well to injection and RD PU
