9/16/21 - MIRU and NU BOP. RIH with JB/GR to 8000'. Set CIBP at 7972', tagged. Spotted 12 sx Class H cement on top to 7682', tagged. Contacted Kevin Bussell with BLM-Roswell on high tag. Omit 2nd CIBP and continue with cement plug 3.

9/17/21 – Spotted a 45 sx Class H cement plug from 7682'-7328' calc TOC. Spotted a 25 sx Class C cement plug from 6927'-6678' calc TOC. Spotted a 25 sx Class C cement plug from 6172'-5904' calc TOC.

9/21/21 – Circulated 5-1/2" casing clean from 5879' and up to surface. Perforated at 5830'. Pumped a 45 sx Class C cement plug from 5830'-5652' calc TOC.

9/22/21 – Tagged TOC 5419'. Perforated at 5010'. Pumped a 50 sx Class C cement plug from 5010'-4764', tagged.

9/23/21 - Pressure tested casing from 2463' up to surface, good. Perforated at 2855'. Circulated down 5-1/2" casing and returns up 8-5/8" casing to surface. Pumped 40 sx Class C cement from 2855'-2595', tagged.
