Actual Procedure: 9/20/2021: Drill 17.5 inch surface hole to 635 ft. Run 13.375 inch 54.5 lb J55 surface casing to 619 ft. Pump 40 bbls gel with CTB-15, followed by 565 sks of 13.5 ppg lead cmt, 260 sks of 14.8 ppg tail cmt. Drop plug and displace with 90 bbls of brine. Temp log showed top of cement at 95 ft. Pumped 34 sks of 14.8 ppg until cement came to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
