



SITING AND HYDRO-GEOLOGICAL REPORT FLORANCE U 006

SITING CRITERIA 19.15.17.10 NMAC

Depth to groundwater at the site is estimated to be well in excess of 100 feet (ft.) below ground surface (bgs). This estimation is based on data from Stone and others (1983) and depth to water data obtained from a deep ground bed cathodic protection well located east of the site. The data was obtained within the New Mexico Oil Conservation Division's online well files. Local topography and proximity to adjacent water features were also reviewed.

There are no water wells permitted by the New Mexico State Engineer's Office within 200 ft. from the below-grade tank (BGT) (Figure 1). A topographic map (Figure 2) demonstrates that the BGT is not within 100 feet of any continuously flowing watercourse, significant watercourse, lake bed, sinkhole, wetland, or playa lake as measured from the ordinary high water mark.

LOCAL GEOLOGY AND HYDROLOGY

This particular site is located on a cliff top north of the San Juan River, in between Pump and Caballo Canyons. The site is hundreds of feet higher in elevation than the San Juan River. The cliff top is composed of San Jose Formation sandstone. Topography is dominated by the eroded surfaces of the Nacimiento Formation whose slopes are capped by the resistant sandstones of the San Jose Formation.

Groundwater is estimated to be greater than 300 ft. bgs. This estimation is based on Google Earth's aerial photography (Imagery date: 10/5/2016) elevation difference between the site's ground level (6,069 ft.) and Hilcorp Inc.'s Riddle A Com 260 well site (5,762 ft.) whose cathodic protection well recorded water at 30 ft. bgs (attached). The site is located at 36.792606,-107.738343 or approximately 0.97 miles, N85.5E from the BGT. In addition, depth to water at the closest proximity to Pump Canyon Wash (ground level elevation: 5,667 ft.) is approximately 10 ft. bgs. This point is located at 36.785646,-107.736021, or approximately 1.2 miles, S69.5E from the BGT (see Figure 3A).

REGIONAL GEOLOGY AND HYDROLOGY

The San Juan Basin is situated in the Navajo section of the Colorado Plateau and is characterized by broad open valleys, mesas, buttes and hogbacks. Away from major valleys and canyons topographic relief is generally low. Native vegetation is sparse and shrubby. Drainage is mainly by the San Juan River, the only permanent stream in the Navajo Section of the Colorado Plateau. The San Juan River is a tributary of the Colorado River. Major tributaries include the Animas, Chaco and La Plata Rivers. Flow of the San Juan River across the basin is regulated by the Navajo Dam, located about 30 miles northeast of Farmington, New Mexico. The climate is arid to semiarid with an average annual precipitation of 8 to 10 inches. Soils within the basin consist of weathered parent rock derived from predominantly physical means mostly from eolian depositional system with fluvial having a lesser impact.

Cretaceous and Tertiary sandstones, as well as Quaternary Alluvial deposits, serve as the primary aquifers in the San Juan Basin (Stone et al., 1983). The San Jose Formation of Eocene age occurs in both New Mexico and Colorado, and its outcrop forms the land surface over much of the eastern half of the central basin. It overlies the Nacimiento Formation in the area generally south of the Colorado-New Mexico border and overlies the Animas Formation in the general area north of the State Line. The San Jose Formation was deposited in various fluvial-type environments. In general, the unit consists of an interbedded sequence of sandstone, siltstone, and shale. Thickness of the San Jose Formation increases from west to east.

Groundwater is associated with alluvial and fluvial sandstone aquifers. The occurrence of groundwater is mainly controlled by distribution of sandstone in the formation. The reported or measured discharge from numerous water wells completed in the formation range from 0.15 to 61 gallons per minute (gpm) and with a median of 5 gpm. Most of the wells provide water for livestock and domestic purposes. The formation is suitable for recharge from precipitation due to overlying soils being sandy, highly permeable and absorbent. Low annual precipitation, relatively high transpiration and evaporation rates and deep dissection of the formation by the San Juan River and its main tributaries all tend to reduce the effective recharge to the formation. Aquifers within the coarser and continuous sandstone bodies of the Nacimiento Formation of Paleocene age are between 0 and 1,000 feet deep in the majority of the basin as well (Stone et al., 1983).

This is Harvest's standard procedure for all BGTs. A separate closure plan will be submitted for any BGT closure which does not conform to this plan.
