12/9/21 – MIRU and NU BOP. Tested casing to 500 psi for 15 min, held good. Spotted a 25 sx Class “C” cement plug from 1452’-1194’ calc TOC. No tag. Spotted a 25 sx Class “C” cement plug from 882’-629’ calc TOC. No tag. Perforated at 224’. Established injection rate. Squeezed with 60 sx Class “C” cement from 224’ and circulated up to surface. Topped off wellbore with cement. Visual cement to surface.

12/17/21 - Cut off wellhead and installed dry hole marker. Cut off anchors and cleaned location. **WELL IS PLUGGED AND ABANDONED.**
