

Release psi. Pump plug @ 8405'-8205'. (25 sxs). TOH laying down 59 jts. Pump plug @ 6500'-6250'. (25 sxs). TOH laying down 74 jts. Reverse circulate. Set packer @ 4209'. Test packer @ 500 psi.
 - 11-2-21. Open well with 0 psi on tbg & casing. R/U W-L. Perf @ 4650'-4649'. POOH & R/D W-L. Pump in @ 2 BPM @ 500 psi. Pump plug @ 4650'-4496'. (55 sxs). WOC & Tag. Release packer TIH & Tagged @ 4460'. TOH laying down 41 jts. Set packer @ 2939'. Test casing @ 500 psi. R/U W-L. Perf @ 3280'-3179'. POOH & R/D W-L. Pump in @ 2 BPM @ 500 psi. Pump plug @ 3280'-3180'. (35 sxs). WOC & Tag.


