The original APD noted that Tap Rock would drill from 9-5/8" shoe to KOP with 8-3/4" bit and then downsize to an 8-1/2" bit for the curve and lateral. Tap Rock requests to downsize the curve and lateral to 6-3/4" bit rather than 8-1/2" bit.

Also, Tap Rock requests to change the unit size from the previously permitted 320 acre unit to a 640 acre unit.

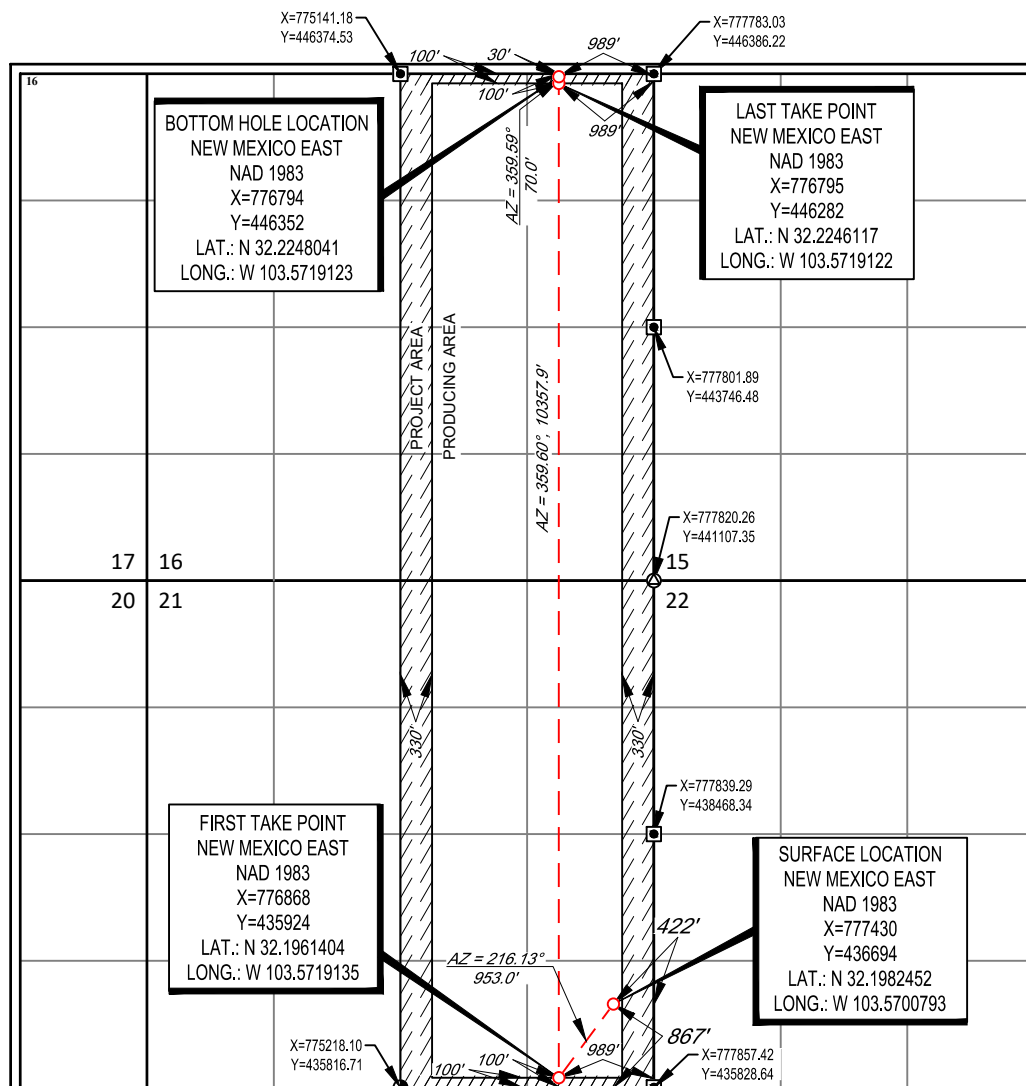

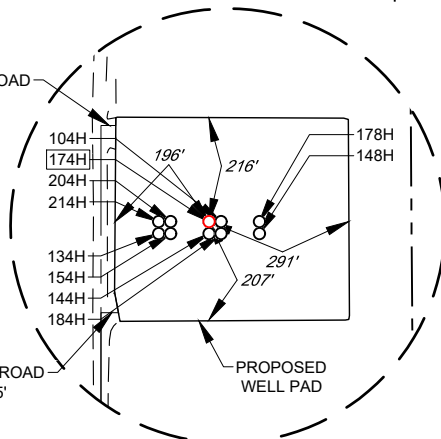
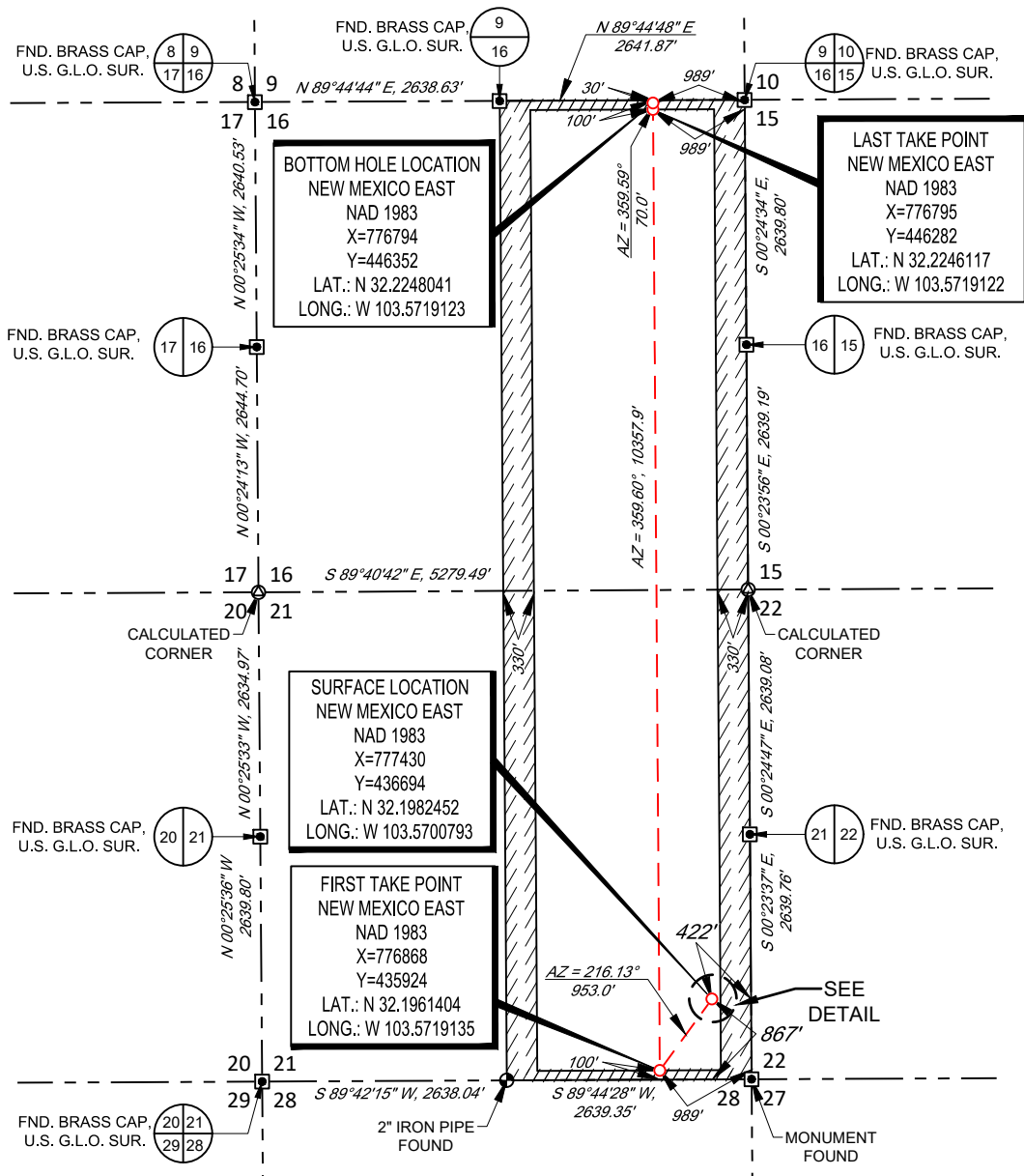
