 12/16/21 – MIRU and NU BOP to continue plugging. RIH and tagged CIBP at 2395'. Pressured up to 500 psi for 15 min, held good.
 Spotted 25 sx Class "C" cement on top to 2148' calc TOC. No tag. Perforated at 1120'. Established injection rate. Squeezed with 65 sx Class "C" cement from 1020'-708', tagged.
 12/17/21 – Perforated at 150'. Established injection rate. Squeezed with 50 sx Class "C" cement from 150' and circulated up to surface.
 Topped off wellbore with cement. Visual cement to surface.
 12/23/21 – Cut off wellhead and installed dry hole marker. Cut off anchors and cleaned location. **WELL IS PLUGGED AND ABANDONED.**
