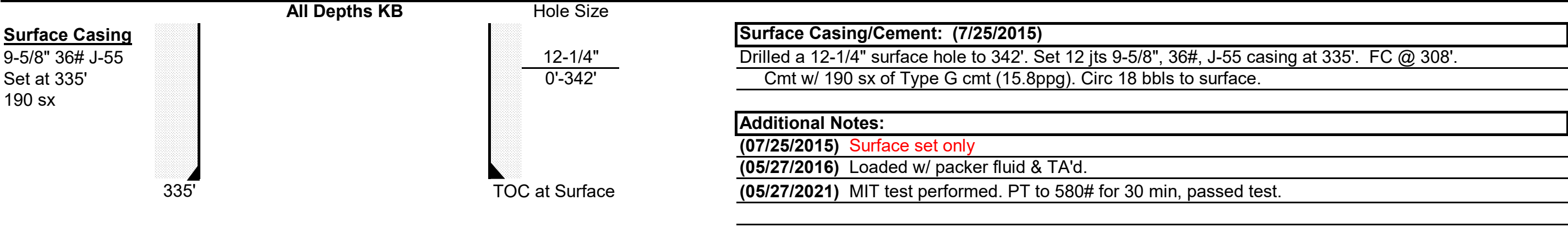

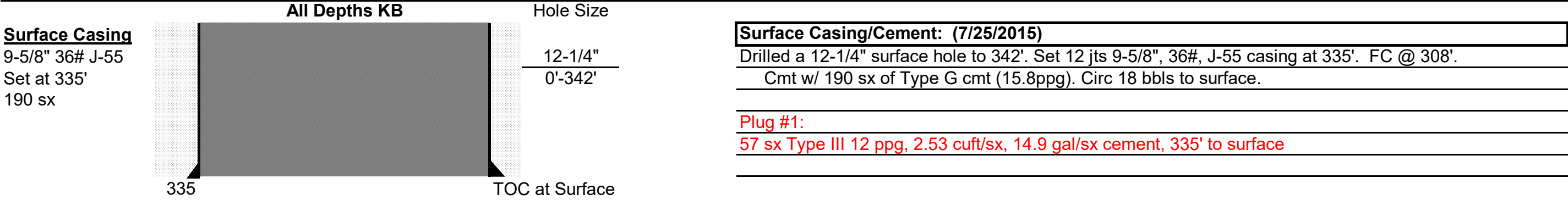

Objective:

- Permanently “Plug & Abandon” 9 5/8” 36# J-55 LT&C surface casing. Casing set depth is at 335’, TD at 342’.

Prior to Job:

- Notify BLM.

Procedure:

- Mobilize cement equipment to location.
- NU on well head with a diverter.
- Hold Pre-Job safety meeting with all involved parties.
- Tally / TIH with PVC.
- Logos rep will confirm that 9 5/8” is full of fluid.
- Rig up cementing equipment. Fill PVC with fluid and confirm circulation.
- Pump ~57 sx Type III 12 ppg, 2.53 cuft/sx, with ~20 bbls of mix water. No displacement.
- Cut PVC and leave in the wellbore.
- Cut off 9 5/8” casing 3’ or greater below GL and install a ¼” or greater steel plate.
