Procedure Description: Dugan Production intends to perforate and complete the well in the Fruitland Coal formation, from approximately 948'-974' (26') w/4 spf, 104 holes, total. We plan to put the well on artificial lift and put the well on production after perforating by means of a sucker rod pump. If hydraulic fracturing is found necessary, we will frack the well with 80,000 gals 70Q foam gel and 100,000 lbs sand. We also plan to run a Correlated Gamma Ray Spectrum log to determine the tops. The available log is a Reservoir Saturation log run in 2009. A CBL was run to verify cement to surface. Both existing logs are on file w/NMOCD. 5-1/2" casing pressure tested to 3000 psi for 30 minutes on 07/21/2001. Casing held good. There won't be any new surface disturbance associated with this work. All wireline & hydraulic fracturing equipment will use the existing well pad and access roads. No workover pits are necessary for this work. If needed, a 150 bbl laydown steel half-pit will be used to collect any fluids during the completion procedure and taken to an approved commercial land-farm. The planned work start date is immediately after regulatory approval. Expected completion date for the work in December 2021.
