- Kill well x ND WH x NU BOP x Unset TAC x POOH LD tbg
- PU WS and RIH with 7.0" CIBP x Set CIBP @ 4,050' x Dump 35 sx cmt on top CIBP
- WOC. Tag @ 3950' or higher**
- Circulate 12# Plug mud
- Perforate at 2700' & attempt to squeeze 190 sx under packer**
- WOC and Tag @ 2425' or higher (Yates + Squeeze Hole Plug)**
- Perf @ 1780' and sqz 190 sx of cmt under packer**
- WOC and Tag @ 1500' or higher (Rustler + Csg Shoe + Squeeze Hole plug)**
- Perf @ 320' and sqz 210 sx of cmt. Circulate to surface.**
- Top-off as necessary (Surface / Csg Shoe plug)**
- Cut off wellhead and install dry hole marker (verify cement to surface all string) with labeling
- Clean up location, remove anchors

During this procedure we plan to use the closed-loop system with a steel tank and haul contents to the required disposal per ODC Rule 19.15.17

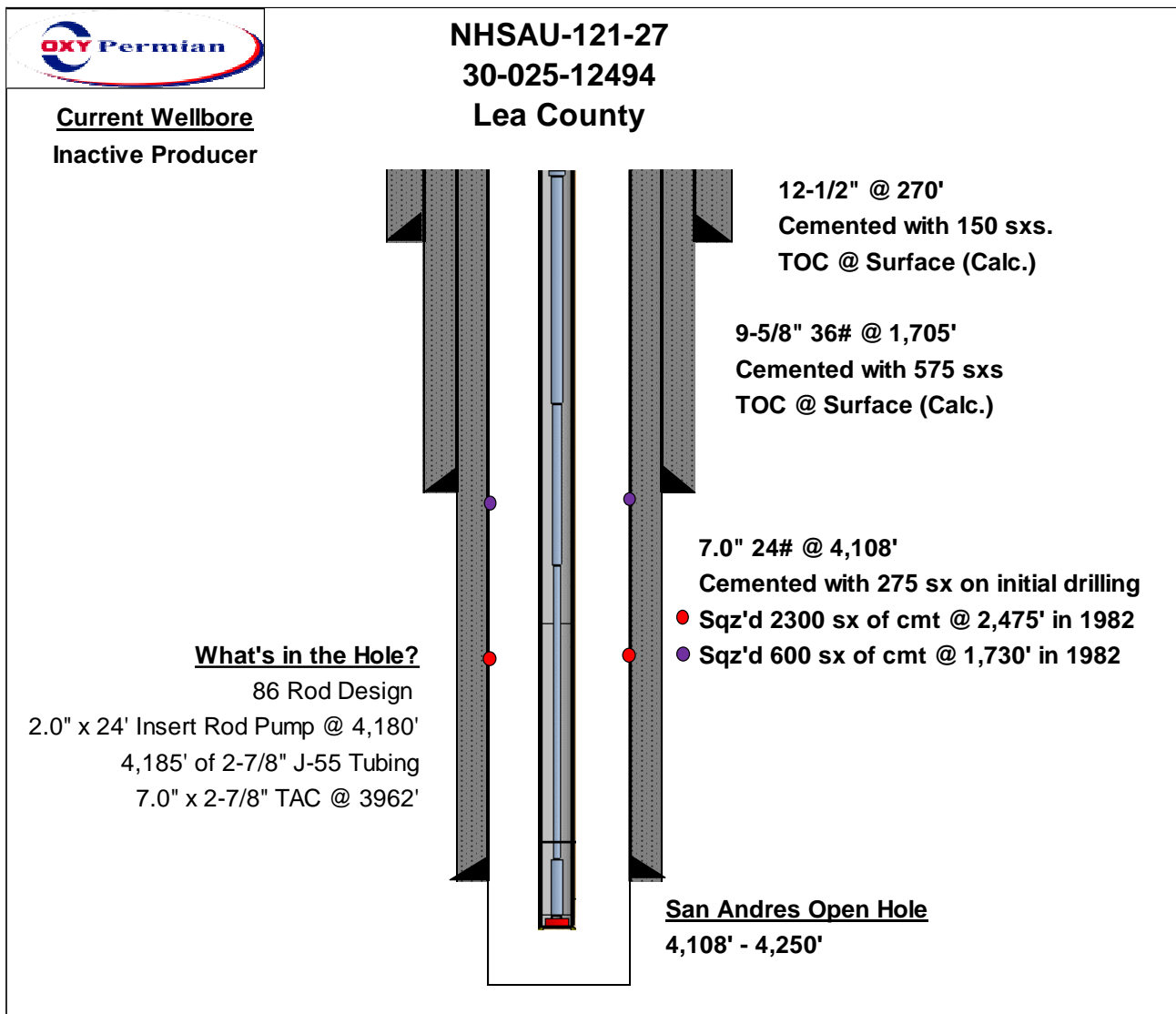

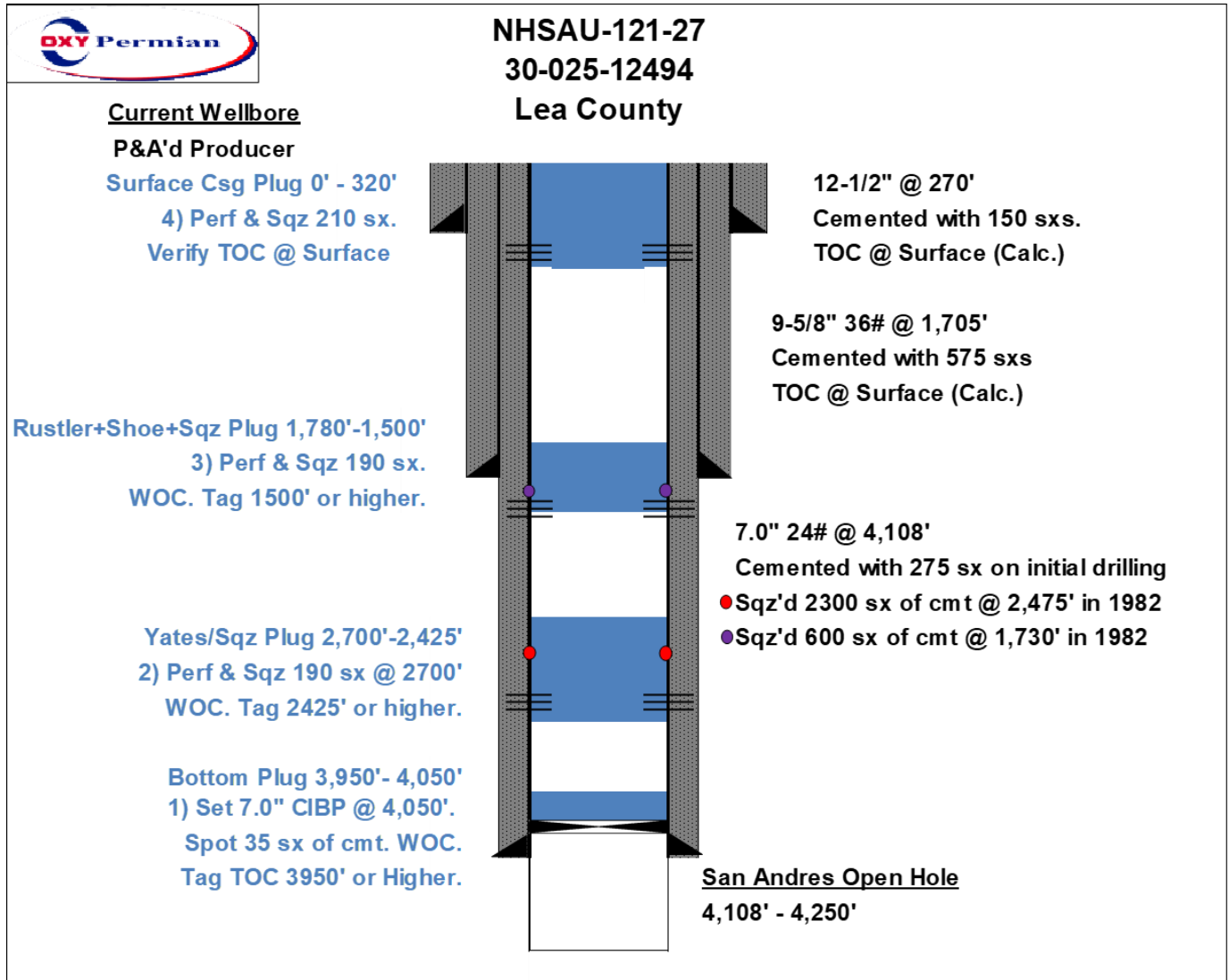
