CASING REPAIR PROCEDURE

GALLEGOS CANYON UNIT #085 – API 3004513075

990' FNL & 990' FEL – A SEC 19 T28N R12W

- 1. Hold pre-job safety meeting. Comply with all NMOCD, BLM safety, and environmental regulations. Test rig anchors prior to moving in rig if not rigged to base beam.
- 2. Check casing, tubing, and bradenhead pressures.
- 3. Remove existing piping on casing valve. RU blow lines from casing valves and begin blowing down casing pressure. Kill well as necessary. Ensure well is dead or on a vacuum.
- 4. ND wellhead and NU BOP. Function test BOP.
- 5. Pressure test tubing to 500 psi. If it holds pressure, pressure test casing.
- 6. TOOH w/ production tubing.
- 7. Test wellhead for communication between casing strings.
- 8. If pressure test fails, pick up tools and identify leak depth.
- 9. Once identified, rig up cement package and squeeze Class G cement as necessary.
- 10. Pick up bit and drill out cement.
- 11. Conduct MIT with NMOCD.
- 12. Unload well, retrieve any plugs and mill packer. TIH with 2 3/8" production tubing. RDMO.
