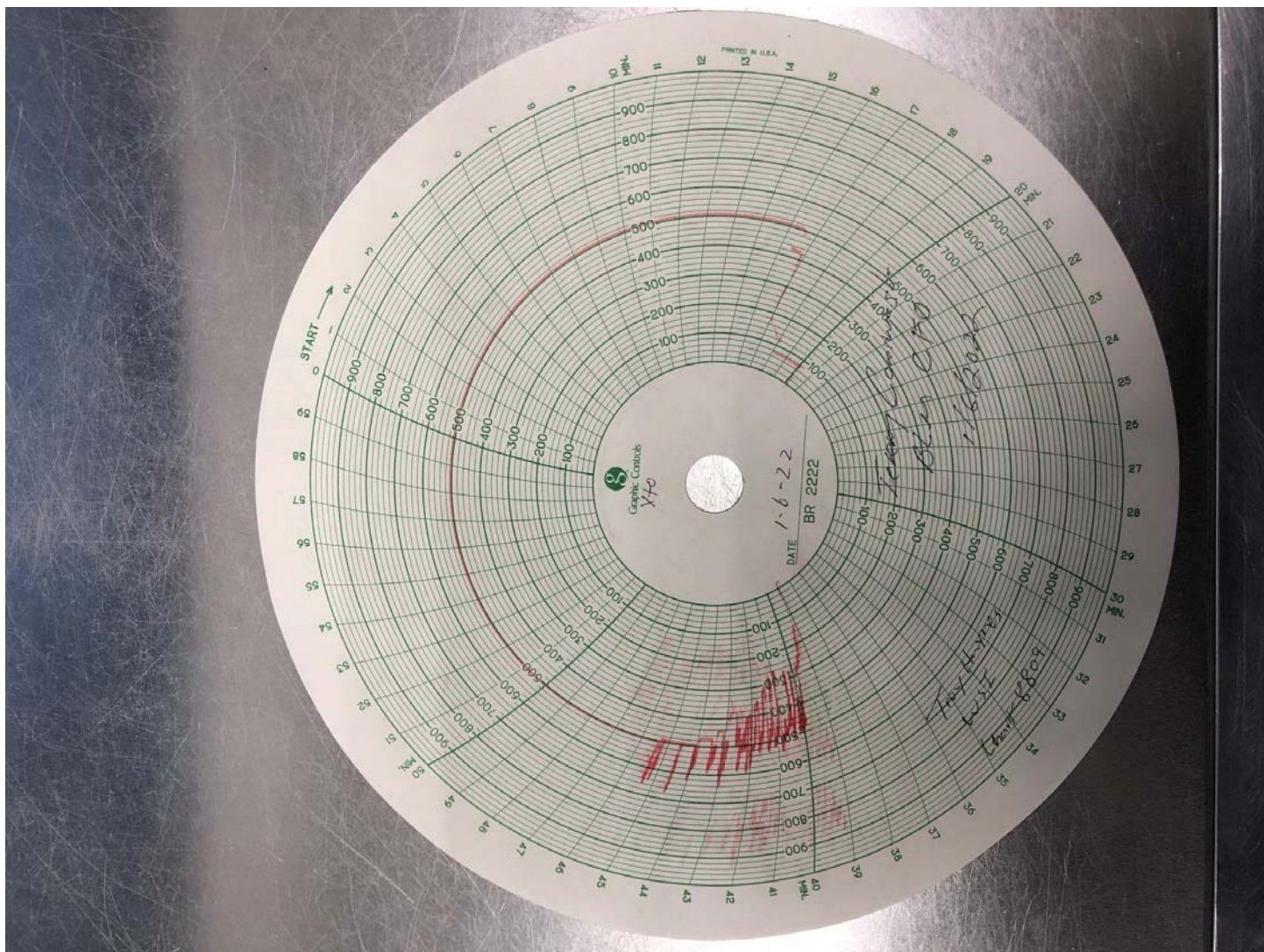

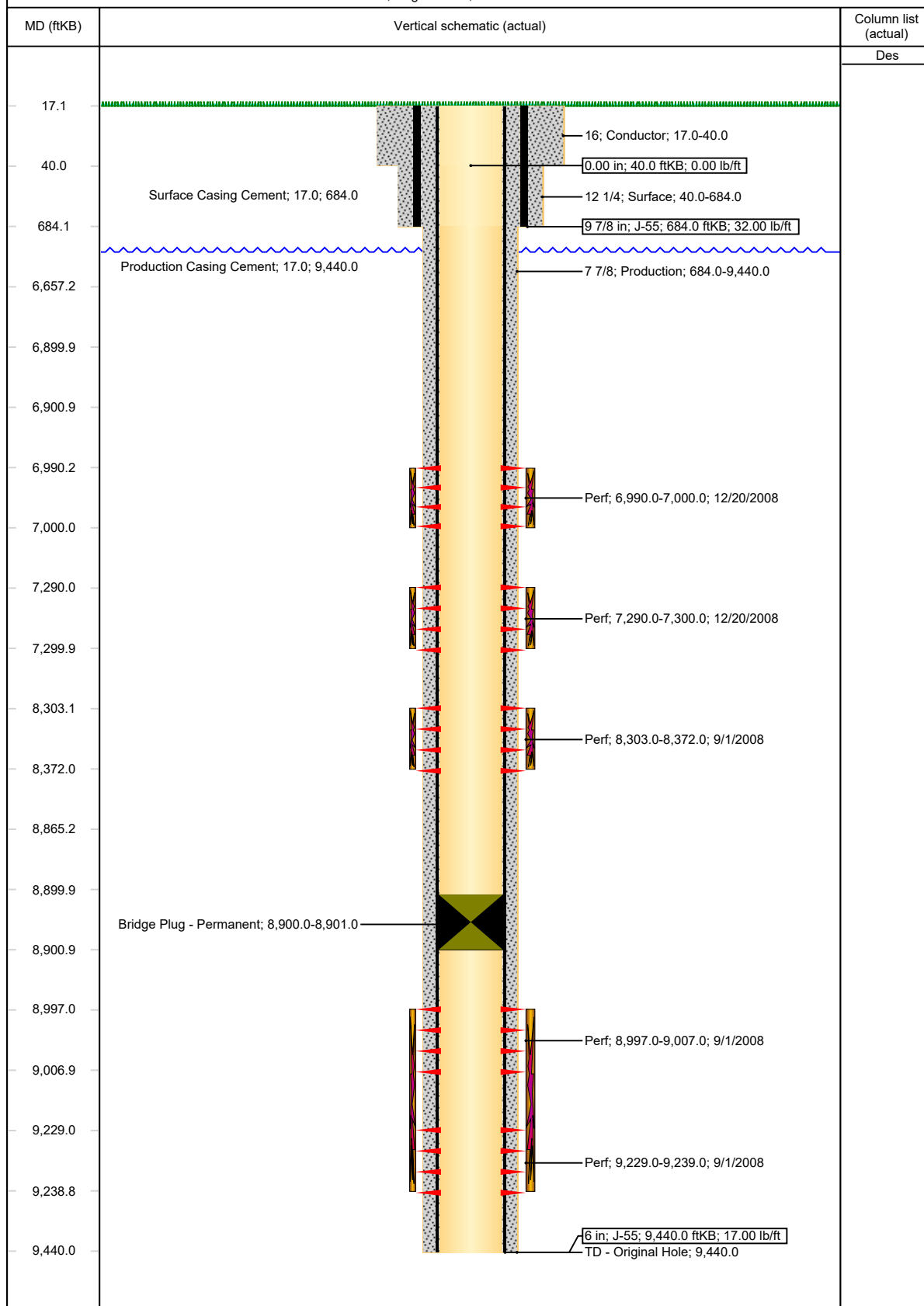


Schematic - Vertical
