Hold PJSM prior to begin all operations. Properly document all operations via the JSA process. Ensure that all personnel onsite abide by HEC safety protocol, including PPE, housekeeping, and standard guidelines. Verify cathodic protection is off and wellhead instrumentation is properly disconnected from the wellhead. Comply with all NMOCD, BLM, and HEC safety and environmental regulations. Verify there is no H2S present prior to beginning operations. If any H2S is present, take the necessary actions to ensure that the location is safe prior to beginning operations. Observe and record pressures across all strings daily, prior to beginning operations.


Remember to notify NMOCD & BLM 24 hours prior to starting operations on location. This procedure is contingent upon P&A sundry approval by NMOCD and BLM.

# **TA Procedure**

- 1. MIRU workover rig and related equipment. Record pressures on all strings of the wellbore.
- 2. ND who and NU BOP. Test BOP. Release the high and tag for fill. TOOH with the production tubing.
- 3. MU 4.5" casing scraper and RIH. Reach +/- 4,175' and POOH.
- 4. MU 4.5." CIBP and RIH. Set CIBP at 4,144'.
  - a. Top Mesa Verde perf at 4,194'
- 5. Load wellbore with inhibited packer fluid and circulate wellbore clean. TOOH with tbg.
- 6. Contact NMOCD 24 hrs prior to pressure test. Test casing to 560 psi for 30 min on a chart recorder (2 hr chart). Contact engineer if pressure test fails.
- 7. ND BOP and NU whd. RDMO workover rig & equipment.




# **CURRENT WELLBORE SCHEMATIC**

  - a. Proposed exact expiration date (day, month, year). Can not be greater than 12-months from date of submission. The date can also be when the current TA approval will expire.
  - b. Confirmation of other production on lease, or agreement.
  - c. Plans for the well.
- 3. This agency reserves the right to modify or rescind approval. A plug or produce order may still be issued at the discretion of the authorized officer.
