As reflected in the attached, the completed lateral and bottom hole location for the well remains the same. Based on our communications with the NMOCD, we understand the NMOCD will then assign the replacement well under this sundry a new API number, leaving the original, partially-drilled wellbore with its same API number. The original well will be named GAVILON FED COM 604Y (API 30-025-47861). The well we will skid to spud will be named GAVILON FED COM 604H and will be assigned a new API # from NMOCD.
