The WO Hughes #003 has been monitored over the last two years; however, water production subsided on the well sometime in 2018. Since then, by the request of the OCD, the bradenhead has remained open and plumbed to a pit, without the presence of gas or water at surface. Upon shut in for a routine bradenhead test in 2021 it was found that the bradenhead pressure built to 50 psig. Five minutes into the test, water came to surface via the bradenhead and flowed for 10 minutes and then blew down to nothing. The 5 min shut in resulted in a 1-pound pressure build. There was not enough gas present to obtain a sample. Since then, the bradenhead has remained open to atmosphere but plumbed to a pit. The well has been checked during routine operations and there have been no status changes reported. Logos Operating has previously requested to complete P&A Operations on the WO Hughes #003
