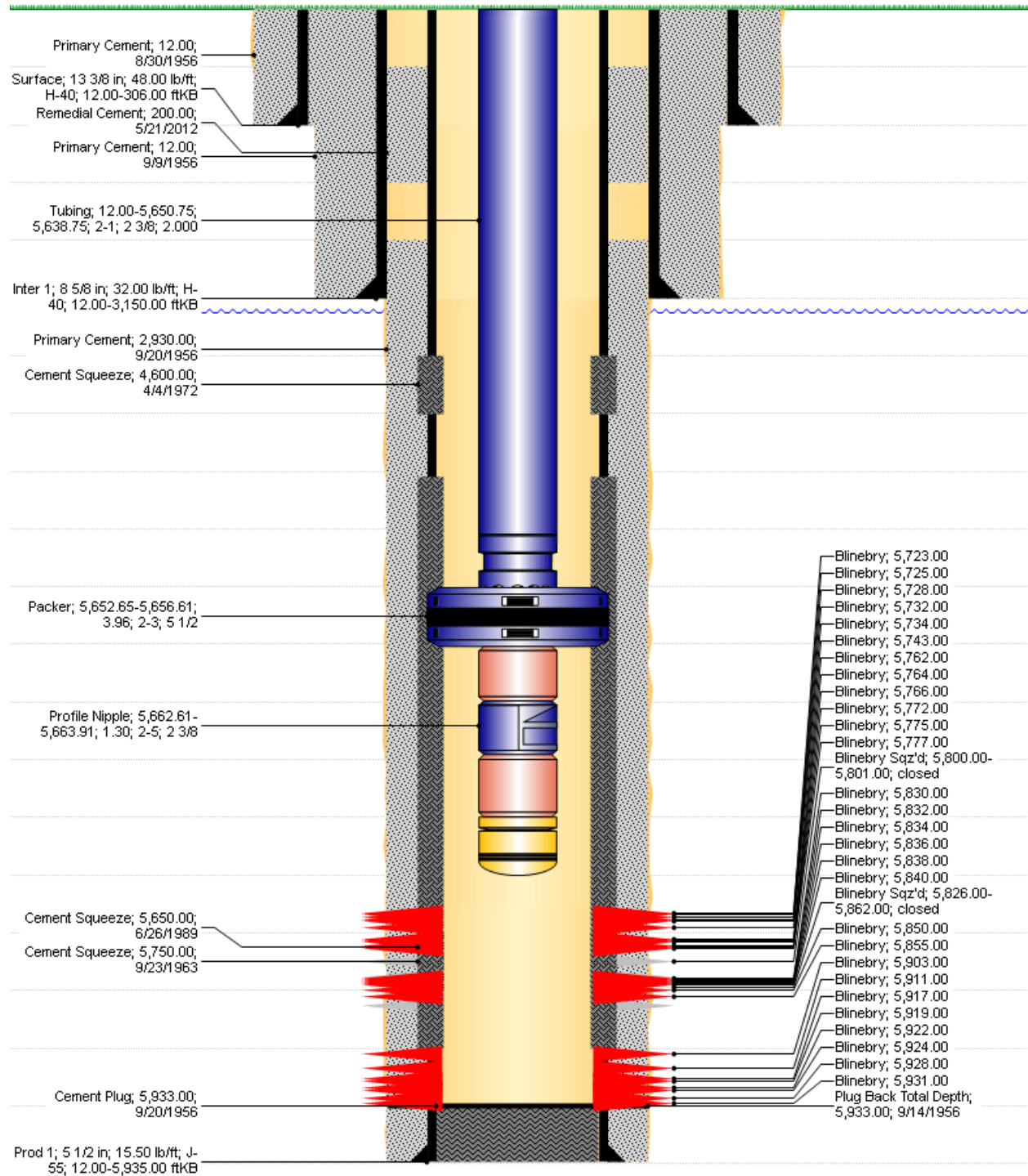

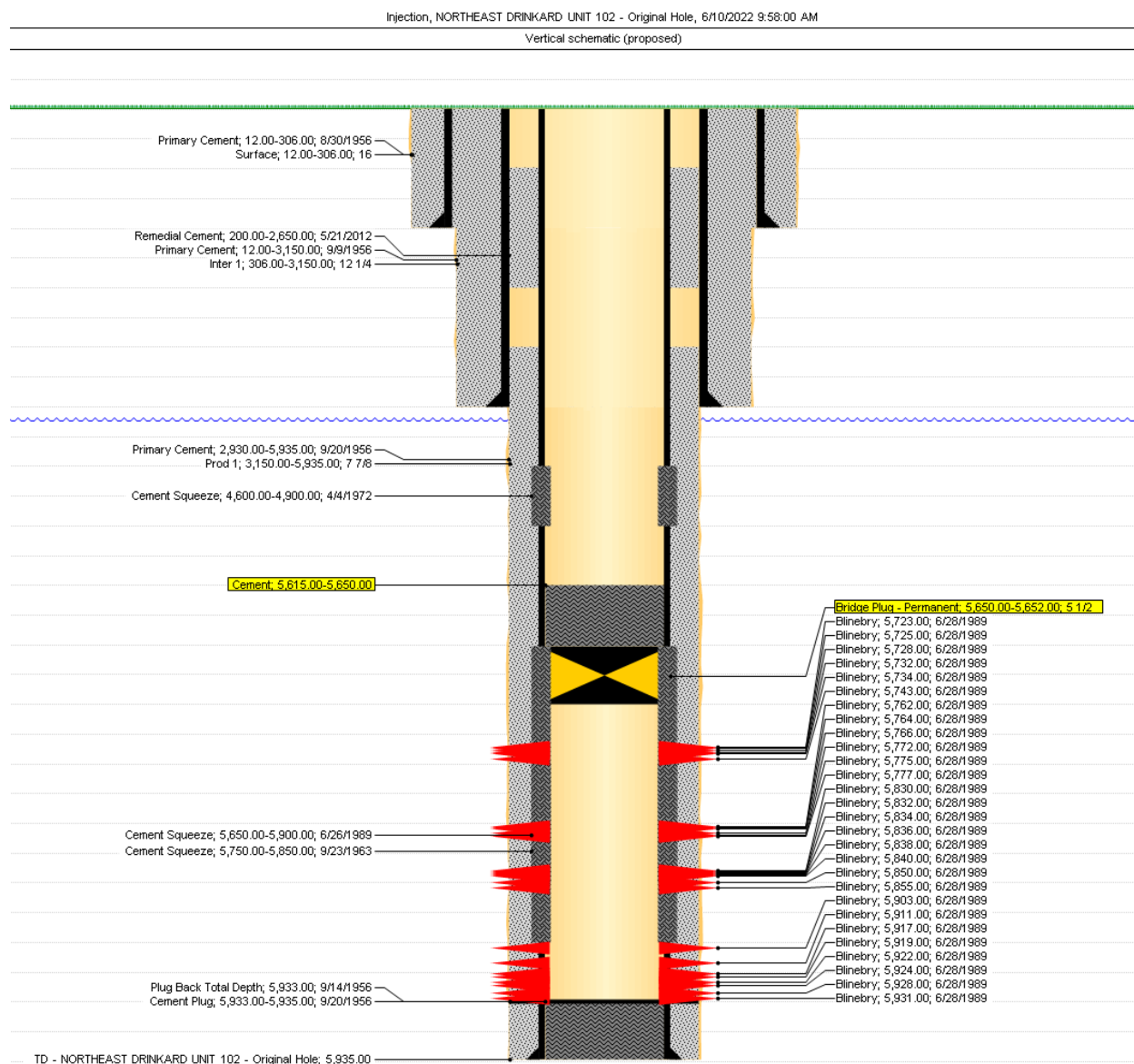

Vertical schematic (actual)

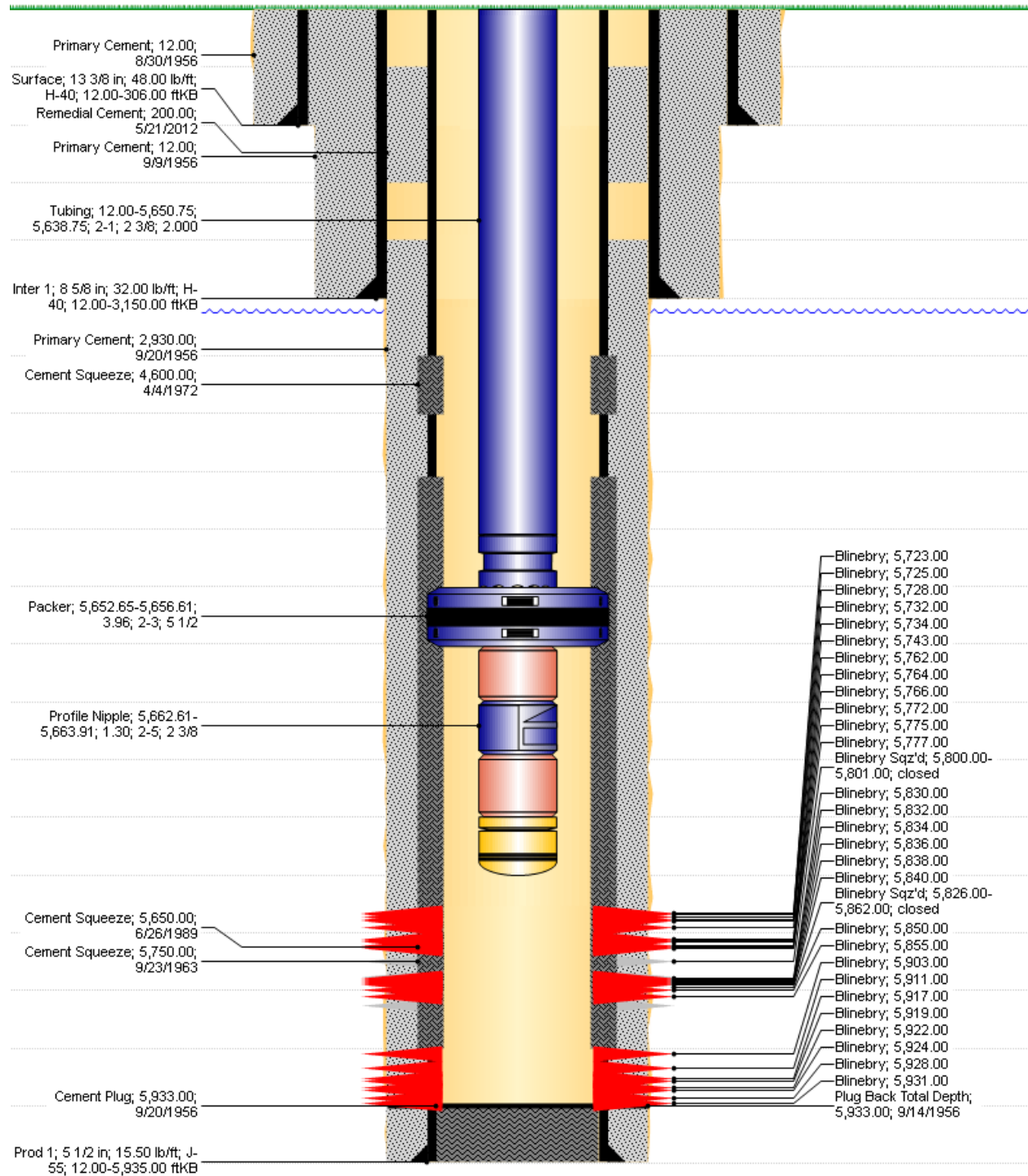


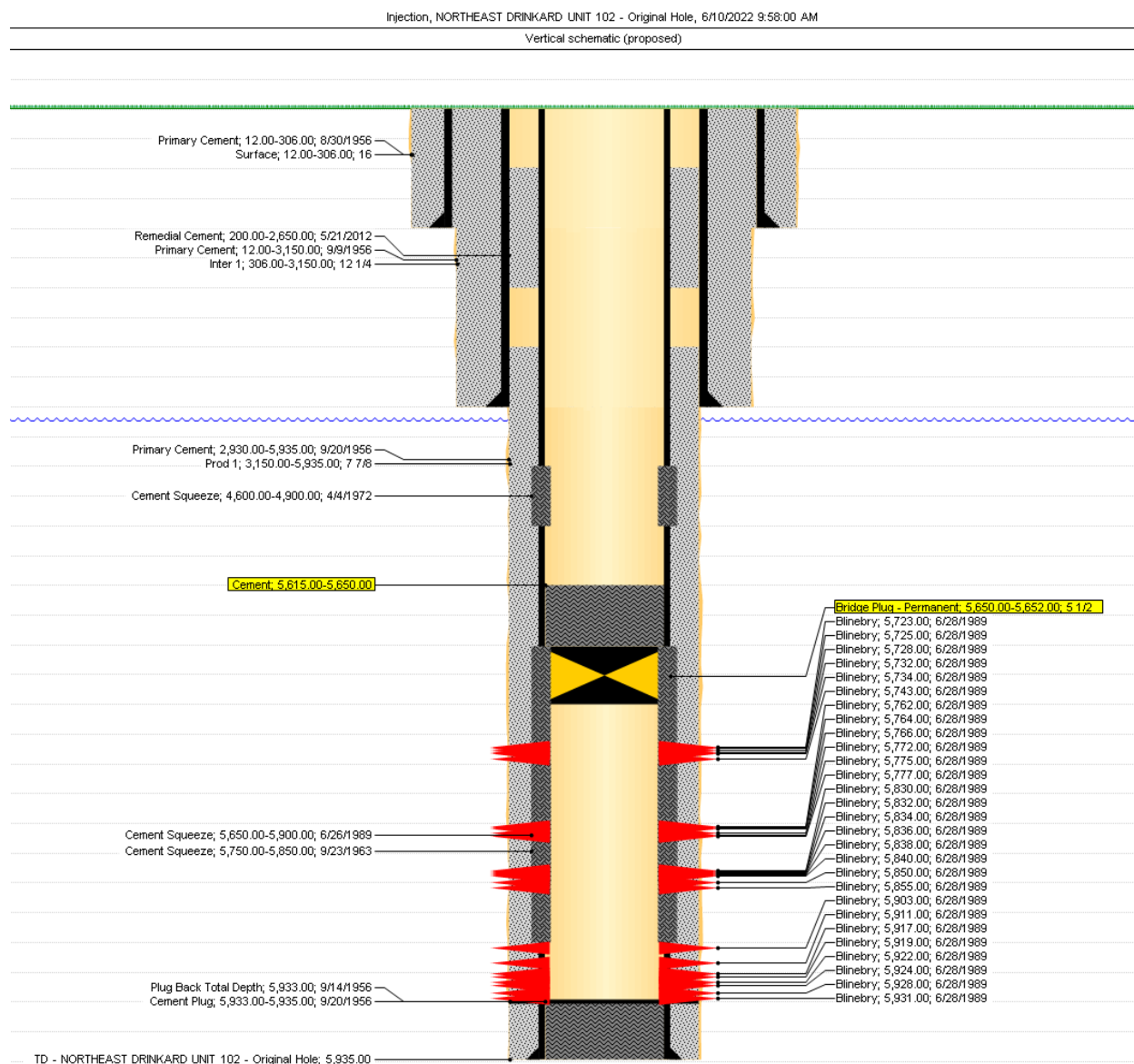
