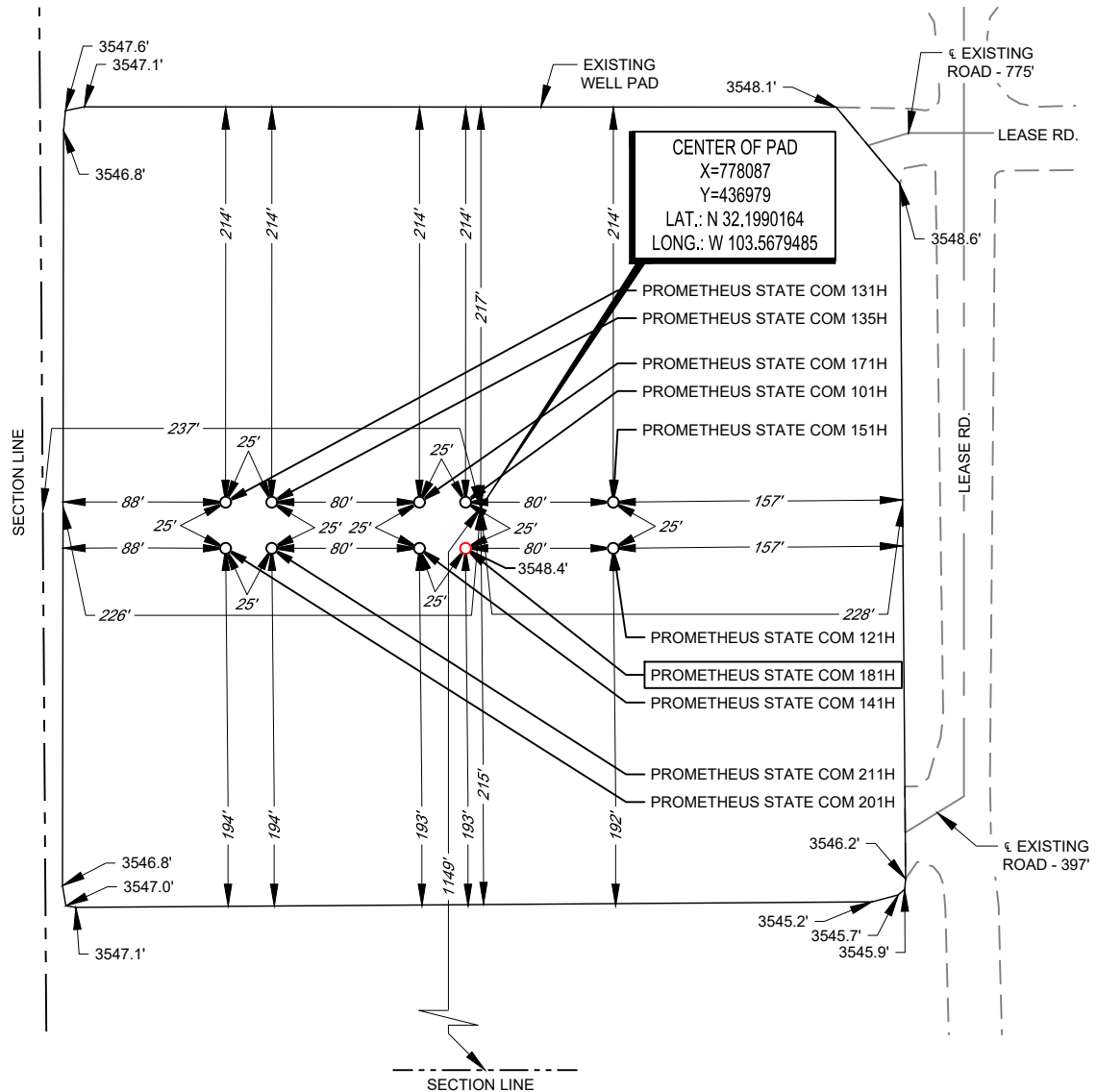

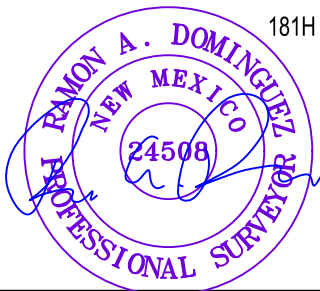

Tap Rock requests the ability to change the OH size currently permitted as 8-1/2" from drillout of intermediate csg to production TD, to instead drill these wellbore sections with the following OH sizes: 8-3/4" vertical to KOP x 6-3/4" curve and lateral. The 8-3/4" OH size in the drillout to KOP vertical wellbore section will keep cementing ECD's lower, helping to ensure overlap in the production cement job. Drilling the curve and lateral as 6-3/4" will allow the rig to drill a smaller hole size for improved drilling efficiencies and fluid management. No changes are being made to the casing design.
