Pump 20 bbls fresh water, 40 bbls gel spacer, followed by 635 sks of 13.5 ppg lead and 445 sks of 14.8 ppg tail. Drop plug and displace with 187 bbls freshwater. 187 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
