- 2) POOH w/ inj eqpt
- 3) RU WL x RIH w/ CIBP & set @ 3950'
- 4) Dump bail 9 sx cmt (35')
 - a. WOC. Tag @ 3915' or higher.
- 5) RD WL x PU WS x Circulate 12# plug mud
- 6) Perf @ 3010' and sqz 230 sx of cmt.
 - a. WOC and Tag @ 2556' or higher (Sqz Hole + Int. Shoe + Base of Salt Plug)
- 7) Perf @ 1840' and sqz 50 sx of cmt.

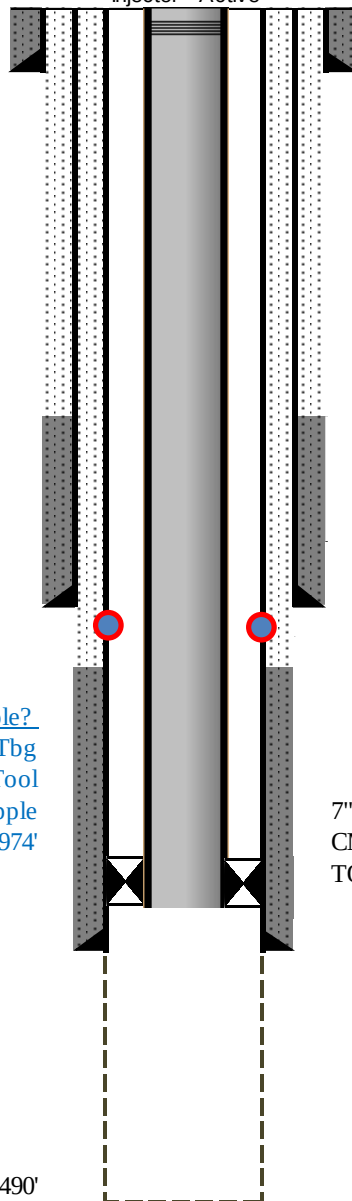

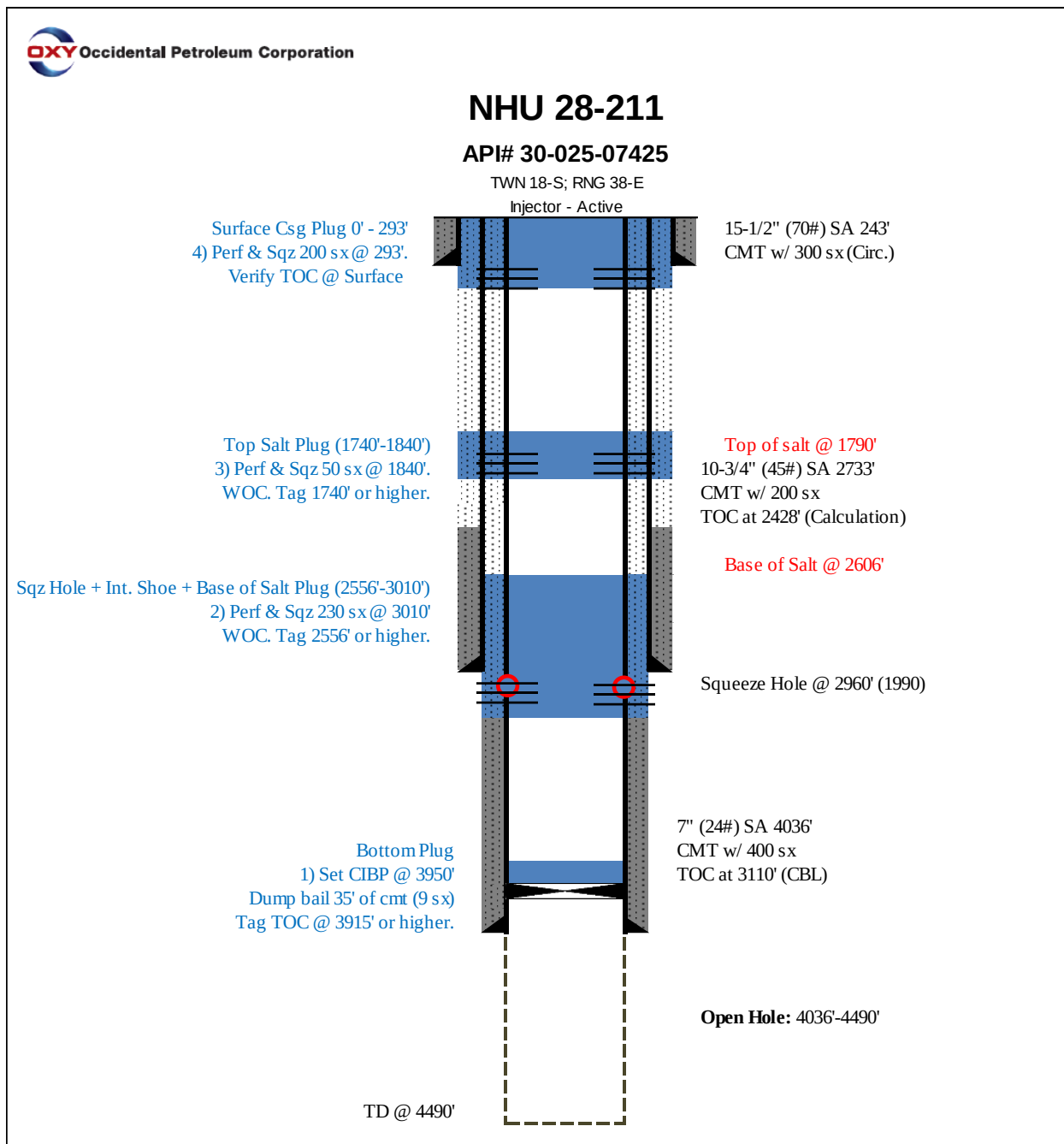
