5/6/22 - MIRU and NU BOP. RIH and washed down to 5961'.

5/10/22 – Spotted a 25 sx Class C cement plug from 5961'-5665', tagged. George Barta with BLM-Carlsbad on location, good with tag.


5/11/22 – Established circulation. Spotted a 25 sx Class C cement plug from 4729'-4482' estimated TOC. RIH with GR/JB and tagged TOC 4410'. (72' high/estimated TOC 4482' and 19' high, proposed CIBP set depth 4429'). Called George Barta and he ok'd to set CIBP at 4400'. Set a CIBP at 4400'. Tagged CIBP at 4412'. Established circulation. Pressured up to 500 psi, good test. Spotted 25 sx Class C cement on top of CIBP to 4146', tagged. George Barta good with tag.

5/12/22 – Perforated at 3610'. Established circulation out 8-5/8" casing. Squeezed with 25 sx Class C cement from 3610'-3460', tagged. George Barta on location to witness tag. Perforated at 1677'. Established circulation out 8-5/8" casing. Called George Barta said to perforate 25' higher at 1652'. Perforated at 1652'. Established circulation out 8-5/8" casing. Squeezed with 103 sx Class C cement from 1652'-1244', tagged. George Barta on location to witness tag.

5/13/22 – Perforated at 800'. Established circulation out 8-5/8" casing. Pumped 200 sx Class C cement in/out from 800' and circulated up to surface. George Barta on location to witness cement to surface.

5/17/22 - Cut off wellhead. Installed above ground dry hole marker as per BLM. Cover cellar and cut off anchors. **WELL IS PLUGGED AND ABANDONED.**
