RIH with 17 jts of 9.625" 36# J55 STC casing set from surface to 380'. FC at 355'. Cement with Type I-II, 20% fly ash, 50% excess as follows: 31.2 bbls (109 sx) 14.5 ppg, 1.61 yield, 7.41 gps. Drop plug. Displace with 26 bbls of water. Bump plug at 800 psi & hold for 5 min. Circulate. 10 bbls good cement back to surface. TOC: surface BOC: 380'. Check float. Float held. RDMO. (Depths have been adjusted for 26' KB of production rig)
