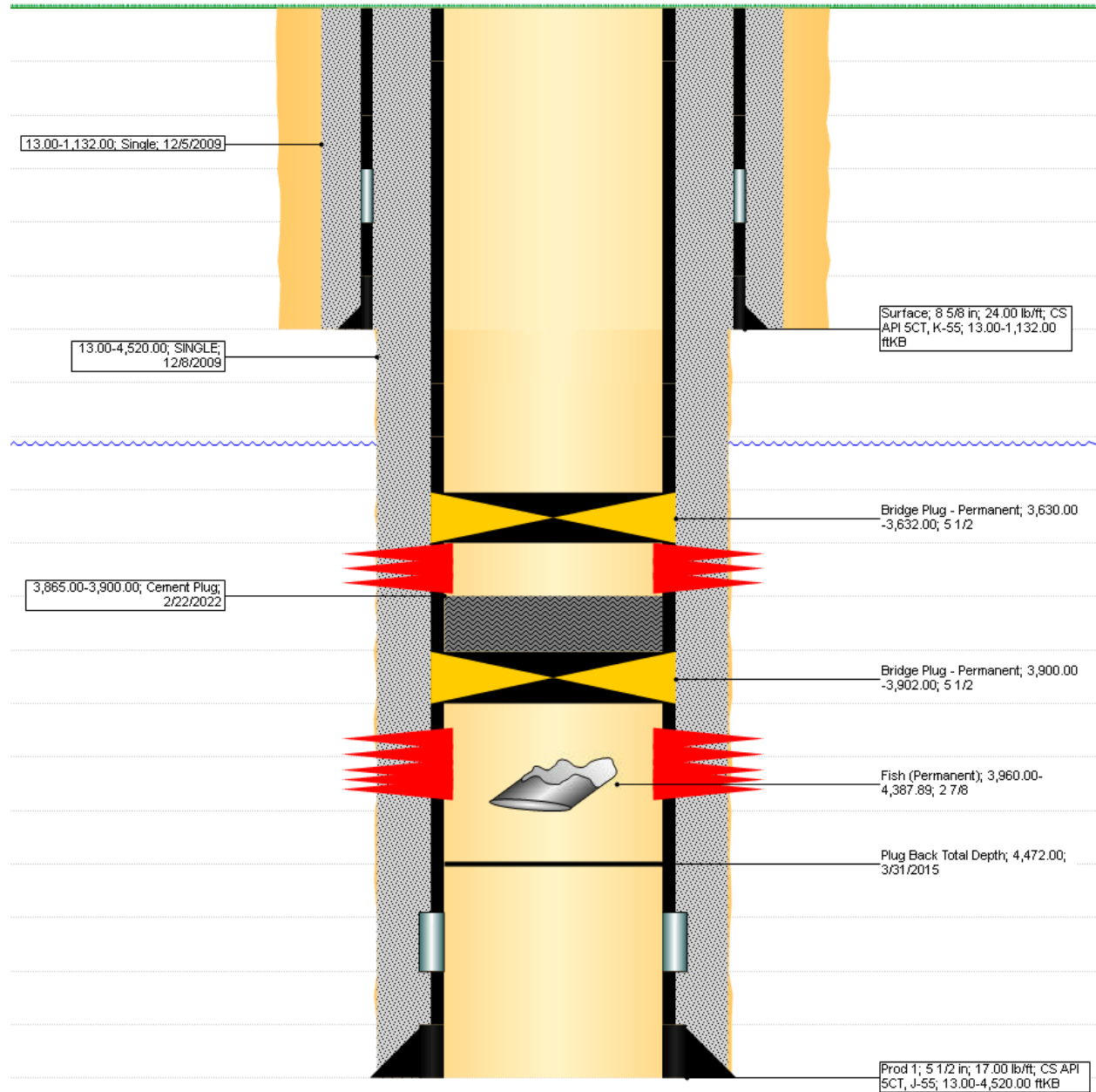

Vertical schematic (actual)

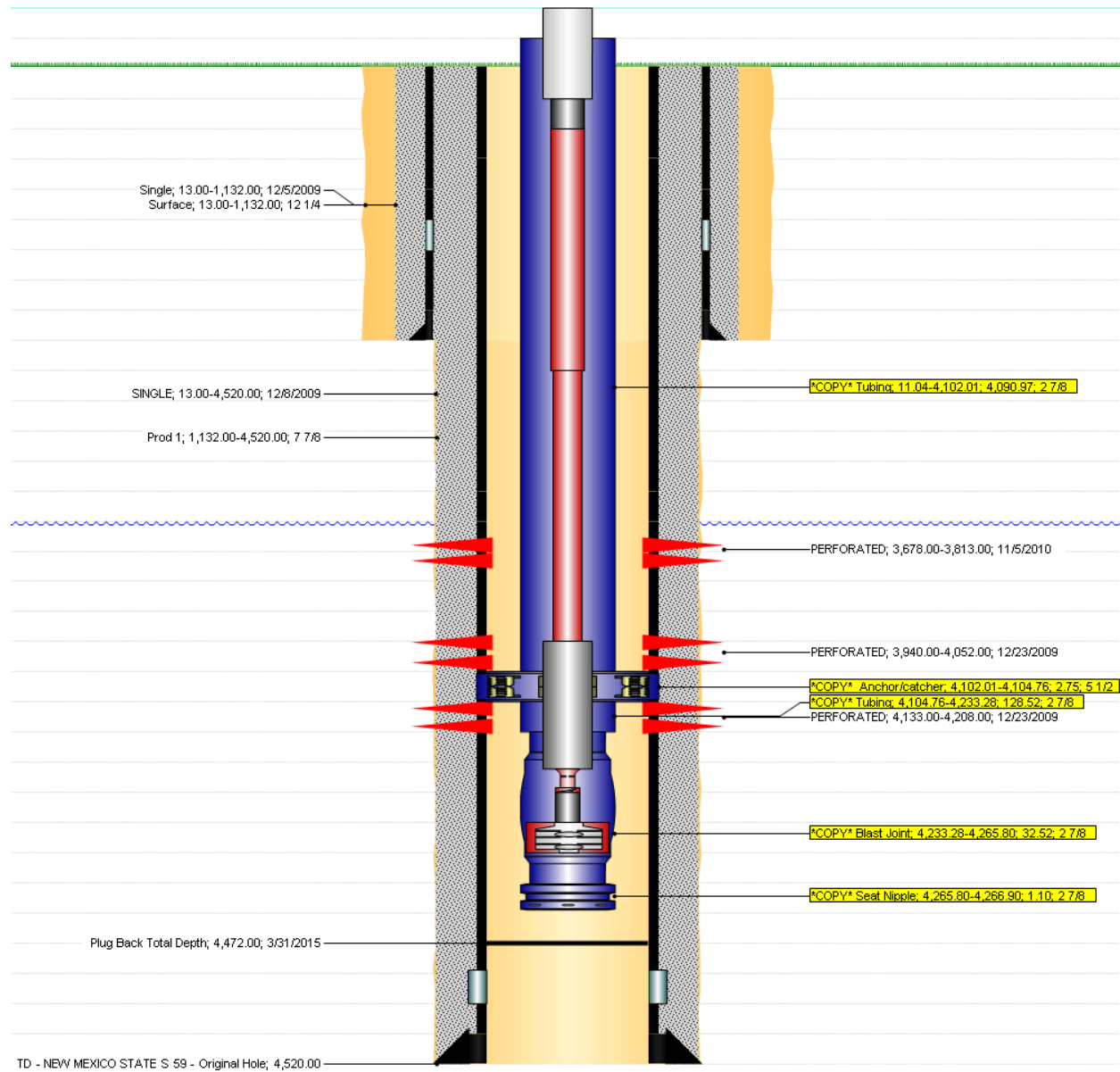




**Proposed WBD**
