**Actual Procedure:** Well spud on 12/3/2021 at 11:15 12/3/2021: Drill 17.5 inch surface hole to 380 ft. Run 13.375 inch 54.5 lb J55 surface casing to 367 ft. Pump 20 bbls gel water and 40 bbls gel spacer, followed by 450 sks of 14.8 ppg lead cmt. Drop plug and displace with 50 bbls brine. 65 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. Surface Casing Details: Casing ran: 12/3/2021, Fluid Type Fresh Water, Hole 17.5 inch, Csg Size 13.375 inch, Weight 54.5 lbs, Grade J55, Est TOC 0 ft, Depth set 367 ft, Cement 450 sacks, Yield 1.35 lead, Class C.
