Regulatory agencies given 24-hr notice of BOP & surface casing PT, James Retherford 505-320-0756. 2/9/22: NU 11" 5K BOPE with installed 11" 5K Cameron wellhead. PT annular and TIW 250 psi low 5 min. 3000 psi high 10 min. Test blind rams, HCR, 4.5" pipe rams, kill valves, check valve, lower kelly, choke manifold and valves, full opening safety valve and inside BOP valve at 250 psi low 5 min. 3000 psi high 10 min. PT pre-set 9.625 inch 36# J55 STC surface casing 1500 psi for 30 min. All tests good and recorded on chart. No regulatory agencies onsite to witness. Drill 8.75" hole from 386' to 4170'. 2/10/22: Drill 8.75" hole from 4170' to 5353'. KOP 4716'. 2/11/22: Drill 8.75" hole from 5353' to 5607'. TOH. RIH with 133 jts of 7" 26# J55 LTC casing set from surface to 5603' MD. 2/12/22: RU cementers. 5000 psi test on lines. Test good. Cement: Class G, 78% excess on lead 0% excess on tail. Lead: 197 bbls (472 sx) 12.3 ppg, 2.34 yield, 13.1 gps. Tail: 37 bbls (141 sx) 13.5 ppg, 1.47 yield, 7.01 gps. Total 613 sx. Bump plug FCP 1460 psi, pressure up to 1963 psi & hold for 5 min. 45 bbls good cement back to surface. TOC: surface BOC: 5603'. No regulatory agencies onsite to witness.
