3. PU and RIH testing with 2 3/8" injection string.
4. Sting into permanent pkr @ 8433'. Pressure test annulus. Sting out of pkr, circulate pkr fluid, sting back. Notify OCD of intent to run MIT.
5. Perform MIT per OCD directive. RWTI.

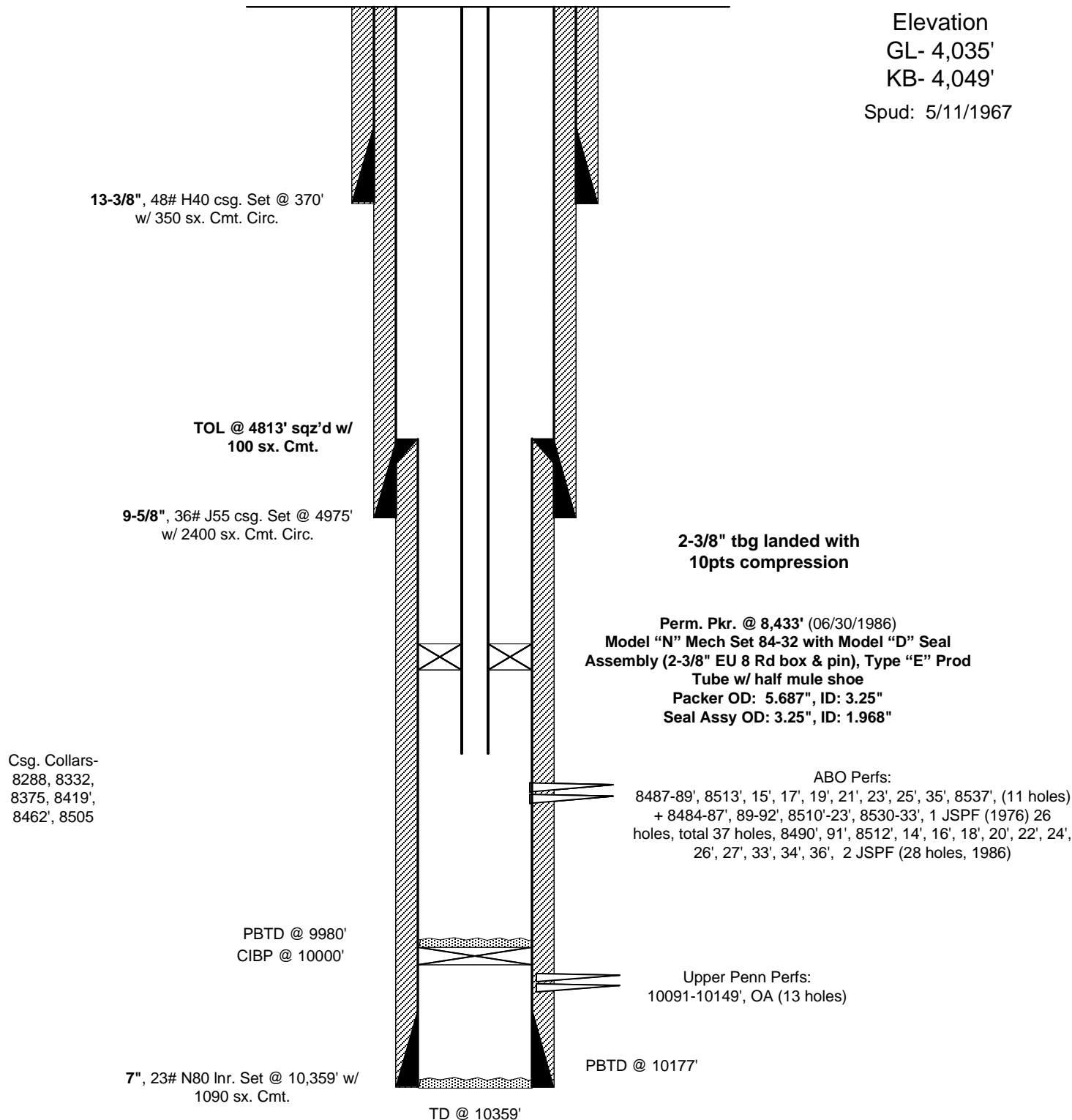
