Planned procedure: Deepening and logging

1. MIRU
2. PU 6-1/8" bit, drillout DV tool and cleanout to float collar @ 5266'. Lay down bit.
3. Perform CBL from 5266' to surface.
4. PU 6-1/8" bit and drillout float collar, shoe track & float shoe. Cleanout to existing TD 5374'.
5. Deepen well from 5374' to 5658' new TD. POOH & lay down bit.
6. Log gyro from ~5000' to 5658'.
7. Perform Triple Combo Log from 5658' to surface.
8. POOH with logging tools
9. Plugback Open Hole by setting CIBP ~5300' topped with 20' cmt
10. Proceed with new well completion per following:
  - a. Perforate San Andres w/ perf interval TBD
  - b. Acidize new San Andres perms w/ ~6000 gal 15% HCl
  - c. Run ESP equipment & put well on production
