6/23/2022: Test BOPS. Drill 12.25 intermediate hole to 5275 ft.

6/24/2022: Run 9.625 inch 40 lb J-55 intermediate casing to 5261 ft. Pump 20 bbls vis water, followed by 950 sks of 11.3 ppg lead cmt, 320 sks of 14.8 ppg tail cmt. Drop plug and displace with 395 bbls fresh water. 175 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 1500 for 30 minutes, good test.

6/25/2022: Drill 8.75 inch production hole to 9505 ft then switch to 6.75 in hole to 20308 ft.

7/7/2022: Run 5.5 inch 20 lb P-110 production casing to 20294 ft MD. Pump 40 bbls fresh water, then 355 sks of 10.5 lead cmt, 1050 sks of 13.2 ppg tail cmt. Drop plug and displace with 20 bbls sugar water and 451 bbls clay stabilized fresh water. 0 bbls returned to surface. Est TOC at 850 ft.
