5/25/2022: Test BOPS. Drill 12.25 intermediate hole to 5316 ft.

5/26/2022: Run 9.625 inch 40 lb J-55 intermediate casing to 5301 ft. Pump 20 bbls spacer, followed by 840 sks of 11.0 ppg lead cmt, 330 sks of 14.8 ppg tail cmt. Drop plug and displace with 399 bbls of fresh water. 100 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 1500 for 30 minutes, good test.

5/27/2022: Drill 8.75 inch production hole to 9957 ft then switch to 6.75 in hole to 20820 ft.

6/4/2022: Run 5.5 inch 20 lb P-110 production casing to 20808 ft MD. Pump 20 bbls gel spacer, then 410 sks of 10.5 lead cmt, 1125 sks of 13.2 ppg tail cmt. Drop plug and displace with 20 bbls sugar water, 439 bbls brine and 10 bbls brine. 0 bbls returned to surface. Est TOC at 1916 ft.
