7/8/2022: Test BOPS. Drill 12.25 intermediate hole to 5318 ft.

7/10/2022: Run 9.625 inch 40 lb J-55 intermediate casing to 5303 ft. Pump 20 bbls vis water, followed by 995 sks of 11.3 ppg lead cmt, 330 sks of 14.8 ppg tail cmt. Drop plug and displace with 20 bbls fresh water and 379 bbls of cut brine. 125 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 1500 for 30 minutes, good test.

7/10/2022: Drill 8.75 inch production hole to 9170 ft then switch to 6.75 in hole to 19946 ft.

7/20/2022: Run 5.5 inch 20 lb P-110 production casing to 19931 ft MD. Pump 50 bbls fresh water, then 255 sks of 10.5 lead cmt, 1945 sks of 13.2 ppg tail cmt. Drop plug and displace with 442 bbls fresh water. 0 bbls returned to surface. Est TOC at 1252 ft.
