6/6/2022: Test BOPS. Drill 12.25 intermediate hole to 5265 ft.

6/8/2022: Run 9.625 inch 40 lb J-55 intermediate casing to 5249 ft. Pump 20 bbls vis water, followed by 840 sks of 11.0 ppg lead cmt, 330 sks of 14.8 ppg tail cmt. Drop plug and displace with 399 bbls fresh water. 100 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 1600 for 30 minutes, good test.

6/9/2022: Drill 8.75 inch production hole to 10433 ft then switch to 6.75 in hole to 21254 ft.

6/18/2022: Run 5.5 inch 20 lb P-110 production casing to 21239 ft MD. Pump 40 bbls fresh water, then 430 sks of 10.5 lead cmt, 1045 sks of 13.2 ppg tail cmt. Drop plug and displace with 20 bbls sugar water and 451 bbls fresh water. 0 bbls returned to surface. Est TOC at 921 ft.
