6/20/2022: Test BOPS. Drill 12.25 intermediate hole to 5333 ft.

6/22/2022: Run 9.625 inch 40 lb J-55 intermediate casing to 5313 ft. Pump 20 bbls spacer, followed by 840 sks of 11.0 ppg lead cmt, 330 sks of 14.8 ppg tail cmt. Drop plug and displace with 397 bbls of fresh water. 105 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 1500 for 30 minutes, good test.

6/23/2022: Drill 8.75 inch production hole to 10536 ft then switch to 6.75 in hole to 21337 ft.

7/2/2022: Run 5.5 inch 20 lb P-110 production casing to 21362 ft MD. Pump 40 bbls gel spacer, then 405 sks of 10.5 lead cmt, 1135 sks of 13.2 ppg tail cmt. Drop plug and displace with 20 bbls retarder and 451 bbls fresh water. 0 bbls returned to surface. Est TOC at 1737 ft.
