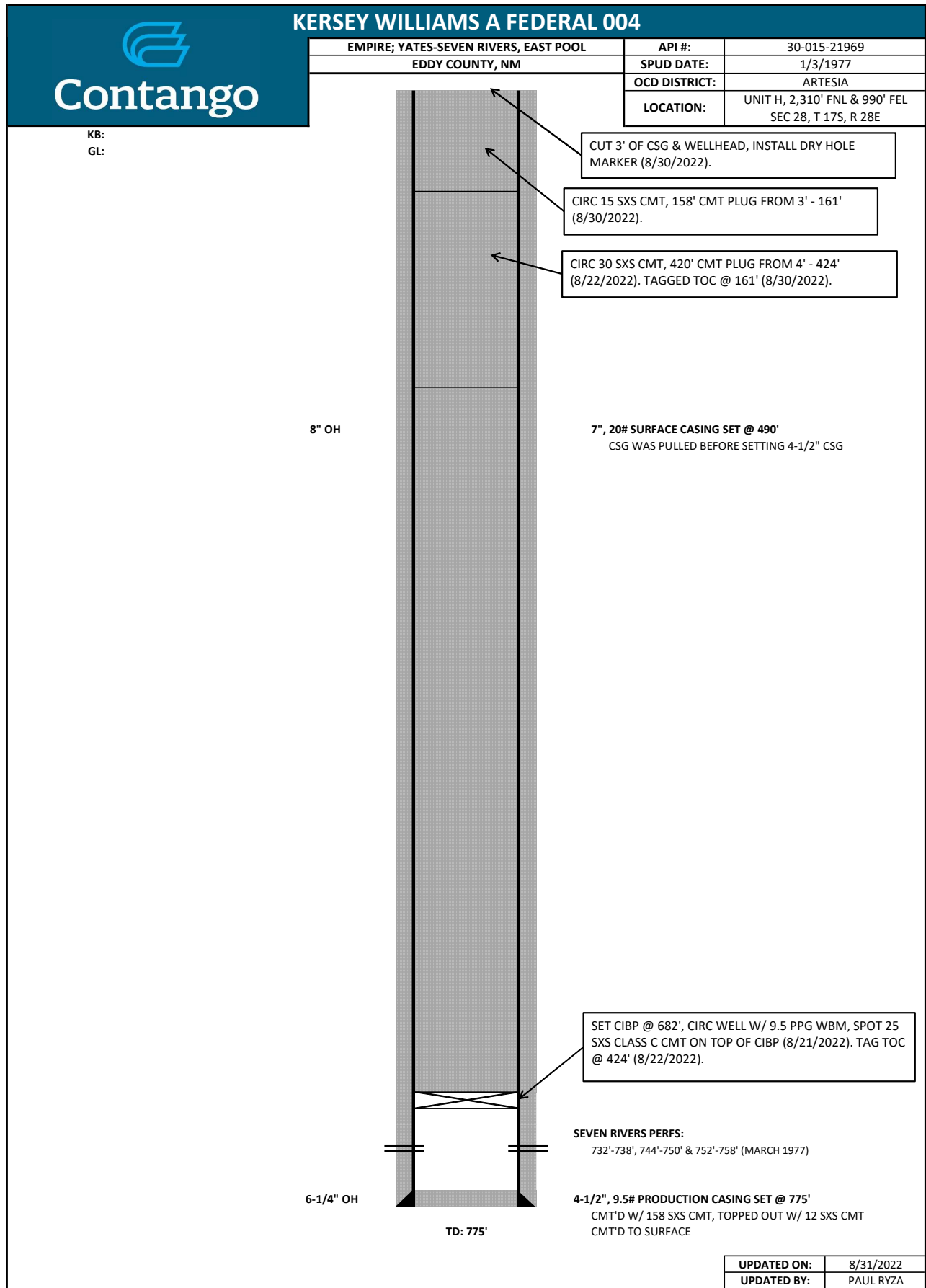

1. MIRU rig. Pulled rods & pump. ND wellhead, NU BOP. Pull tbg (8/19/2022).
2. RIH w/ bit & tbg to 698', POOH, set 4-1/2" CIBP @ 682' (8/21/2022).
3. Spot 25 sxs Class C cmt on top of CIBP (8/21/2022).
4. Tag TOC @ 424', circulate 30 sxs Class C cmt from 424' to surface (8/22/2022).
5. Rig crew on days off (8/23/2022 - 8/29/2022).
6. Tagged TOC @ 161', circulate 15 sxs Class C cmt from 3' - 161', monitored for 3 hours, still have cmt to surface (8/30/2022).
7. Dug up & cut off wellhead 3' below ground level. Verified cmt to surface. Welded steel plate on csg (8/30/2022).
8. Installed 4' dry hole marker. Covered up cellar. Dug up & cut off anchors. Cleaned location. RDMO rig (8/30/2022).
