Full returns throughout job, circ 157 sxs to surface. 3/02/2022 NU BOP, test to 250# low 2500# high, good test. Test 9-5/8" csg to 1500# for 30 minutes, good test. Drill 8-3/4" hole to 4340'V/10068'M – TD reached on 03/07/2022.
